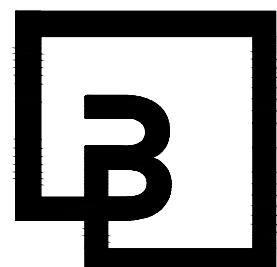


SIGN SITE PLAN
