## NOTICE OF PUBLIC HEARING OF A PROPOSED ORDINANCE MODIFYING FEES COLLECTED BY THE OFFICE OF THE TREASURER-TAX COLLECTOR

NOTICE IS HEREBY GIVEN THAT THE County of El Dorado Board of Supervisors will hold a public hearing on Tuesday, June 30, 2020, at 9:00 a.m., or as soon thereafter as the matter can be heard. To comply with social distancing requirements and the stay at home order issued by Governor Newson on March 4, 2020, all public participation will be via telephone or live stream, pending the lifting of such requirements. At the public hearing, the Board of Supervisors will receive oral and written testimony regarding the adoption of the proposed ordinance modifying fees collected by the Treasurer-Tax Collector Department. The purpose of the ordinance is to align the fees with the cost of providing the services, except where the fee amounts are mandated by California statute. The proposed ordinance also incorporates the Business License Fee Schedule which formerly was adopted by resolution. Incorporating this fee schedule into the ordinance will achieve greater public accessibility and transparency.

A copy of the proposed ordinance and data required by Government Code, Section 66016, indicating the amount of cost, or estimated cost, required to provide services for which the fees will be levied and the revenue sources anticipated to provide the services, will be available for public review at least 10 days prior to the public hearing in the Treasurer-Tax Collector Department, 360 Fair Lane, Placerville, CA 95667.

This Ordinance shall take effect thirty (30) days following adoption thereof.
