Petco Love is taking action to reduce vaccine preventable diseases (parvovirus, distemper and panleukopenia) by allocating three million pet vaccines to our animal welfare partners to distribute for FREE to family pets. These vaccines include Canine DAPPv and Feline HCP. This unique program is designed to increase the number of vaccinated family pets, not only to improve the lives of family pets, but to decrease the spread of disease should these pets enter shelters.

Once your application is approved, vaccines will be delivered directly to your organization. You may submit reorders as often as once per week, monthly or as needed using this form. A required quarterly grant report will be assigned for all participating organizations and must be accurately completed.

REQUIREMENTS FOR PARTICIPATION

Organizations must agree to utilize the vaccine campaign toolkit (link will be sent in approval email), this includes but is not limited to the following:

• Provide the pet parent survey form to each pet family receiving vaccines

• Recognize Petco Love as the provider of the free vaccines in all media outlets regarding vaccine clinic/events, including but not limited to social media posts, website, press release, flyers, etc.

NOTE - Organizations that participate in adoptions are also required to complete a current Annual Data Report (ADR) to qualify for free vaccines. This also includes organizations placing reorders. **ADRs are due March 31st every year**. If you are not in compliance with your ADR then your vaccine request will be sent back.

USE OF VACCINES

Note: this initiative is not for shelter or foster pets.

• Please do not place any limitations on the distribution of these lifesaving vaccines to family pets, such as breed, altered status, location, etc.

- Vaccines must be provided to community family pets for FREE.
- We prefer event style clinics but understand some organizations may only be able to include these in their existing public facing operations.

• Free vaccines may be combined with other services that you offer such as free or low cost spay/neuter, rabies vaccines and other services, but must not be required.

VACCINE ORDERING SCHEDULE

Petco Love submits an order to our distributor every Monday morning. Please plan ahead and **submit your vaccine request by Thursday morning** for our team to review for possible approval and delivery of vaccines for the following week.

If your application (or reorder) has been approved, you will receive an email notification informing you the vaccines will arrive by end of that week. Our typical cadence is below for reference (Note: most major holidays will result in delays).

Example:

Thursday – submitted applications/reorders are evaluated for approval Monday – order of approved apps sent for vaccine fulfillment Wednesday/Thursday – vaccine orders are delivered

ORDER QUANTITIES/SHIPPING MIN & MAX

When requesting an order please keep in mind your storage capabilities and your vaccine distribution timeframe. Your approval email will list the exact quantity you have been approved for.

Orders come in trays of 25 vaccines. The minimum order must be 12 trays (300 vaccines) with a maximum weekly order is 40 trays (1,000 vaccines). If approved, reorders can be placed on a weekly basis if needed.

We are unable to accept returned excess vaccines. Should you have vaccines left over after an event, please schedule another event to continue using the vaccines for the same purpose. Left over vaccines

may not be used for shelter/foster pets.

Additional support!

We recognize that there is a cost of administering vaccines and therefore will provide an initial stipend of \$3 per administered vaccine. This stipend is based on the total number of administered vaccines reported on your quarterly grant reports.

El Dorado County Animal Services will host free vaccine/microchip clinics several times a year at both the Diamond Springs and South Lake Tahoe animal shelter locations. The clinics would be drive through style clinics with followup booster appointments made and completed at the shelters. Additionally, staff will periodically go into the community to vaccinate and microchip animals owned by unhoused individuals. El Dorado County does not have a veterinarian on staff; therefore, the vaccines will be given by Registered Veterinarian Technicians and Animal Services Officers.
