



RESOLUTION NO. 073-2015  
OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**Resolution to Authorize the Community Development Agency Director to Temporarily Close a Section of Green Valley Road between Lode Road and El Dorado Road and between El Dorado Road and Mallard Lane for the Construction of the Green Valley Road at Weber Creek Bridge Replacement Project During the 2015/2016 Construction Seasons**

**WHEREAS**, the County plans to replace the Weber Creek Bridge on Green Valley Road and to construct other roadway improvements on Green Valley Road for Capital Improvement Project No. 77114 during the 2015/2016 construction seasons; and

**WHEREAS**, a new bridge, pavement and drainage culverts will be constructed as part of the Project; and

**WHEREAS**, this Resolution supersedes Resolution No. 175-2014 that was passed and adopted by the Board of Supervisors on October 14, 2014; and

**WHEREAS**, in order to construct portions of the roadway improvements, Green Valley Road, between Lode Road and El Dorado Road, will need to be closed for no more than six (6) consecutive weeks; and

**WHEREAS**, in order to construct portions of the roadway improvements, Green Valley Road, between El Dorado Road and Mallard Lane, will need to be closed for no more than ten (10) consecutive days; and

**WHEREAS**, an alternate access route/detour will be available during the temporary closures and traffic will be directed by signage to this route/detour; and

**WHEREAS**, pursuant to California Vehicle Code Section 21101 (e), the Board of Supervisors is authorized to temporarily close a portion of any street for the safety and protection of persons who are to use that portion of the street during the temporary closing; and

**WHEREAS**, pursuant to California Vehicle Code Section 21101 (e) and California Streets and Highways Code Section 942.6, the Board of Supervisors may delegate the powers associated with road closures to the County Road Commissioner; and

**WHEREAS**, the County of El Dorado Ordinance Title 12, titled Streets, Sidewalks and Public Places, Chapter 12.04 Administration, Section 12.04.030 Road Commissioner Defined, defines Road Commissioner as Director of the Department of Transportation; and

**WHEREAS**, Chapter 2.14 of the County of El Dorado Code of Ordinance states that any references in the code to the Community Development Director, Development Services Director, Environmental Management Director, the Director of Public Works, or the Director of Transportation shall be understood to refer to the Community Development Agency Director or his/her qualified designated representative;

**NOW, THEREFORE, BE IT RESOLVED** that this Resolution supersedes Resolution No. 175-2014 that was passed and adopted by the Board of Supervisors on October 14, 2014. The Community Development Agency Director is authorized to order the temporary closure of Green Valley Road, between Lode Road and El Dorado

Road, for up to six (6) consecutive weeks and to establish an alternate access route for traffic use during the time of temporary closure. The Community Development Agency Director is authorized to order the temporary closure of Green Valley Road, between El Dorado Road and Mallard Lane, for up to ten (10) consecutive days and to establish an alternate access route for traffic use during the time of temporary closure. The precise dates of the temporary road closures are to be determined by the Community Development Agency Director, with notification of the pending temporary road closure and alternate route to be provided to the County Supervisors, business owners, residents, the general public, the El Dorado County Transit Authority and to safety and law enforcement agencies in the Project area, through direct communications, signage, or flyers.


