ORDINANCE NO. 5102

AN ORDINANCE TO REPEAL SECTION 8.08.020 THEREBY AMENDING ORDINANCE 3528 PERTAINING TO FIRE PREVENTION IN EL DORADO COUNTY

**WHEREAS** the Board of Supervisors (Board) adopted Ordinance 5101 - Vegetation Management on April 30, 2019; and

**WHEREAS** Section 8.09.070 of Ordinance 5101 contains language that supersedes that of Section 8.08.020 thereby rendering 8.08.020 inoperable; and

**WHEREAS** the Board wishes to repeal and reserve section 8.08.20; and

**THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS:**

**Section 1.**

Section 8.08.020 - *Hazard removal required* of Chapter 8.08 - *Fire Prevention* is hereby repealed and reserved for future use.
