At the monthly El Dorado County Mental Health Commission meeting on April 23, 2014, the Commission passed a motion recommending that the Board of Supervisors allocate \$800,000.00 of available Tobacco Settlement Funds to the County's Psychiatric Health Facility building located at 935B Spring St., Placerville, CA, for improvement and repairs of deficiencies and deferred maintenance. This allocation should be included as part of the County's Fiscal Year 2014-2015 Budget approval process.

The deficiencies and deferred maintenance items referred to in the motion are based on the El Dorado County Facilities Capital Improvement Plan, October 28, 2013; Conditions Assessment Report pages 206-208.
