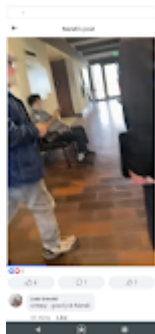

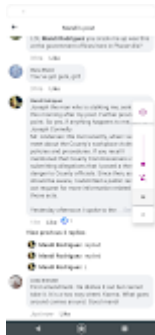

Dear Supervisors:

Last week I objected to the nomination of Linda Grimoldi to the Commission on Aging because she had not disclosed her membership in a group that includes neo-Nazis and Proud Boys, or that she was a moderator of that group. My comments are enclosed for the record.

Despite Ms. Grimoldi's concealment of that membership and her role in its moderation, you voted to continue her nomination to March 22nd. The matter is now scheduled to be heard immediately after Open Forum. (Agenda, file # 22-0389.)

I object to Ms. Grimoldi's nomination as an unsuitable nominee for many reasons. Her undisclosed associations are unbecoming of a County Commissioner and the County's good governance standards. Her lack of disclosure of a divisive group is a poor reflection of her character, and of her Supervisor for forwarding that nomination despite these red flags. Her approval of public harassment following last week's Board meeting is another poor character reflection, as is her ridicule of President Biden as "dementia boy." That slur is a particular insult to a commission focused on "community issues and issues faced by seniors in El Dorado County," such as dementia among seniors. Her nomination for purely political purposes is an affront to an apolitical Board of Supervisors. Please see attached examples.

The public deserves the best commissioners this County has to offer, not your justification of those who fall far short. Please vote no on Ms. Grimoldi's nomination, and please demand a better process that includes proper vetting and background checks to avoid these recurring nomination issues.

I'VE ALREADY DOCUMENTED TO YOU THAT AARON HAS CONNECTIONS TO MANY PROUD BOYS AND SOME NEO-NAZIS, INCLUDING A PROUD BOY WHO WAS IN THE GROUP THAT LED THE ATTACK ON THE U.S. CAPITOL—THIS GROUP RIGHT HERE. (IMAGE 1.) YOU KNOW THAT PROUD BOY'S NAME AND HIS CONNECTION TO AARON BECAUSE I SUBMITTED THEM IN WRITING TO YOU LAST MONTH.

THE BOOTS ON THE GROUND FACEBOOK GROUP MEMBERS INCLUDE ONE OF AARON'S NEO-NAZI FRIENDS, AS WELL AS PATRICK AND BONNIE KIEHL. 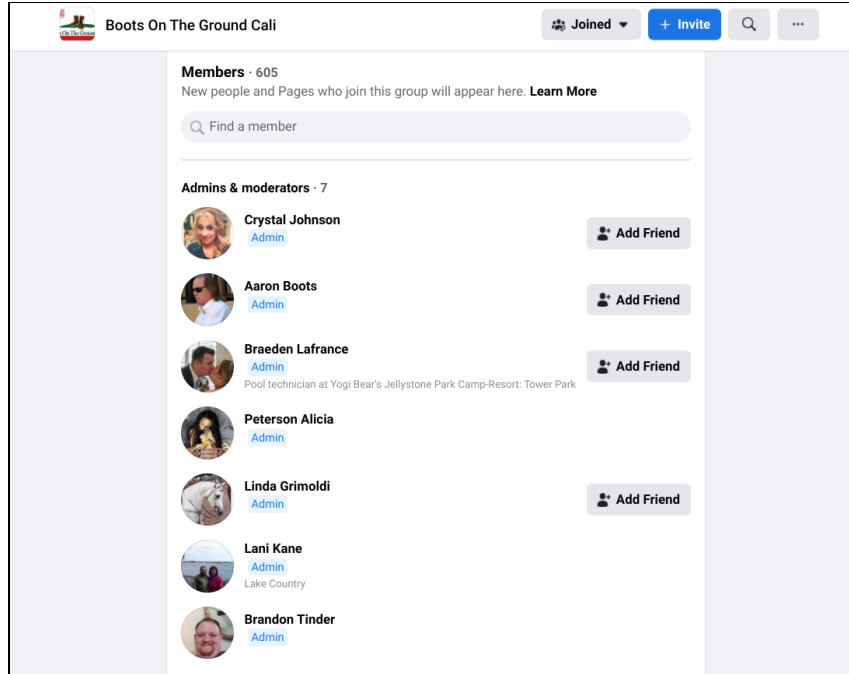

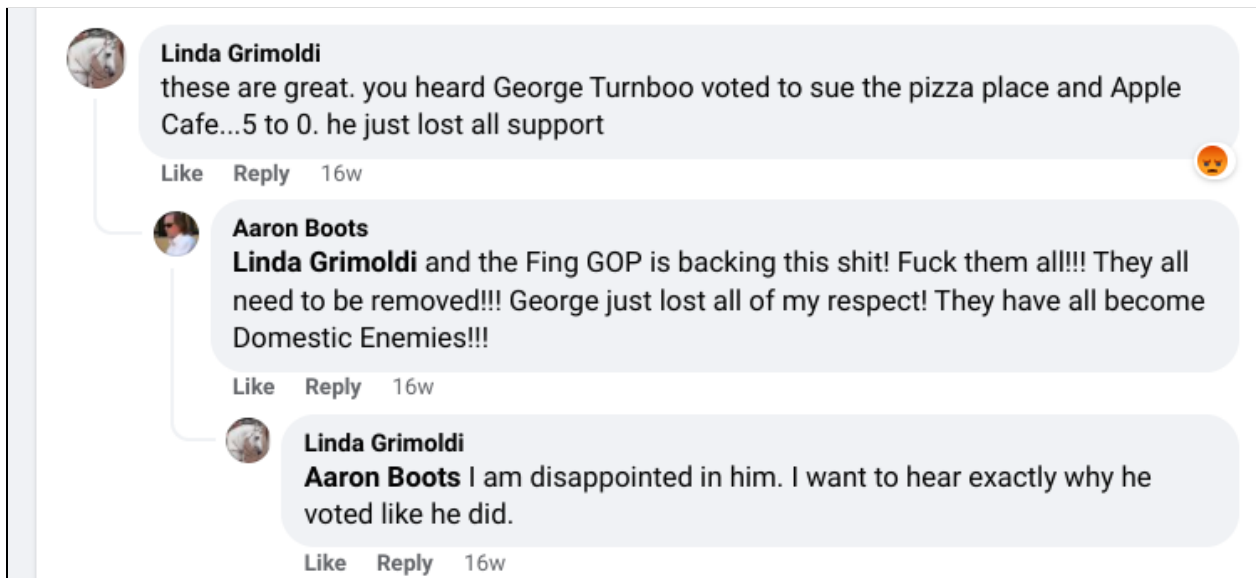

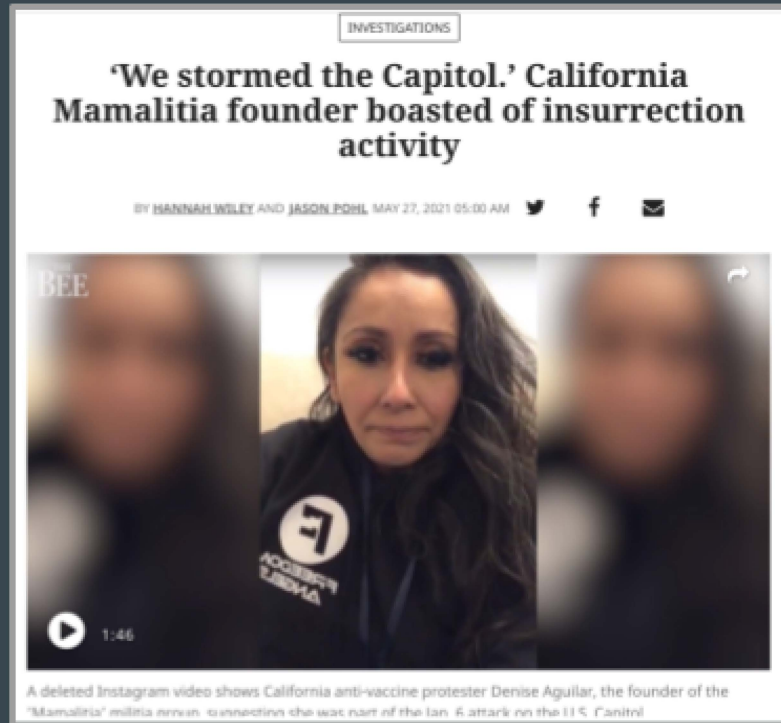

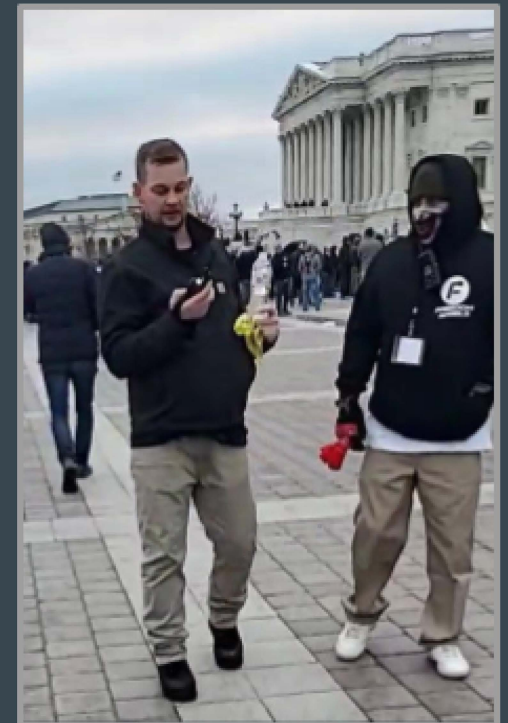

Dear Supervisor,

We look to you for Leadership and to provide for the good of the county.

As a reminder, the Commission on Aging is a non-political commission. The county functions much more efficiently when squabbles between Democrats and Republicans are not included. Thus, the request from the El Dorado County Republican Party to its members to support the appointment of Linda Grimoldi for the Commission on Aging is highly inappropriate. The statement that " her appointment was called into question because of her involvement in the Republican Party" is unfounded.

The Commission on Aging is presently functioning with highly qualified people that are dedicated to their position and to the betterment of seniors in our county.

This non-political group understands their role and supports staff in assisting their Senior Citizen agencies, all to help seniors with needs.

I have to ask, since Linda Grimoldi's application is not presently available, what qualifications does she bring to this functioning and efficient group?

Has she served on other committees? Does she work with seniors or volunteer to help seniors? Does her business/career experience provide skills or background that would be helpful? Does she have experience working with government agencies?

Being a person with a "heart of gold" and a senior herself may not be an adequate qualification.

If you look at Linda Grimoldi's Facebook pages you will note that several of the entries have been fact checked and have incomplete or misleading information. This can only lead me to conclude that Linda Grimoldi is not careful about what she reads or posts. Or, worse, that she has her own opinion that is not to be changed.

Linda Grimoldi will need to be respectful to others on the commission that may have different beliefs from her own. Her comments on FB demonstrate disrespect and impolite language.
