**2024 PROPOSED SOLID WASTE COLLECTION AND MATERIAL RECOVERY FACILITY RATE INCREASES**

Notice is hereby given that a public hearing will be held at 1:15 pm. on Tuesday, June 25th, 2024, by the El Dorado County Board of Supervisors which will be held at the Board of Supervisors Chambers, 330 Fair Lane, Building A, Placerville, California. The public hearing will consider the request by El Dorado Disposal Service to increase solid waste collection rates by 7.5 % for Franchise Areas A, B, and C, and 5.56% for the Material Recovery Facility, to be effective July 1, 2024.
