



RESOLUTION NO. 158-2014

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of El Dorado, State of California, find and declare that \$2,067.45 in unclaimed property tax refunds exist as reported to this Board by the county Auditor-Controller as Exhibit "A" and incorporated into this resolution. The Board directs the county Auditor Controller to transfer these unclaimed property tax refunds to the county general fund in accordance with Revenue and Taxation Code §5102.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of El Dorado, State of California, find and declare that \$33,864.88 in stale-dated property tax refunds exist as reported to this Board by the county Auditor-Controller as Exhibit "B" and incorporated into this resolution. The Board directs the county Auditor Controller to transfer these unclaimed property tax refunds to the county general fund in accordance with Government Code §29802 and Revenue and Taxation Code §5097.
