I would like to express my gratitude and support for your project in our community of Kelsey. With the rural dynamics of our region of El Dorado County we are very limited with both resources and geographical access when it comes to emergency services.

In the 60+ square miles of our Fire District we have very few locations in which we can utilize medical helicopters to transport critical patients to treating facilities. Often times when we call for a medical helicopter, it necessitates the deployment of an additional resource to assist in landing the air-ambulance, taking away a vital resource that we could utilize at the emergency scene.

Through your project in our community, we will be able to have a dedicated location for medical helicopters that we can utilize without concern about impacting our resources on scene of an emergency or a concern about the safety of the landing location for the air-ambulance crew.

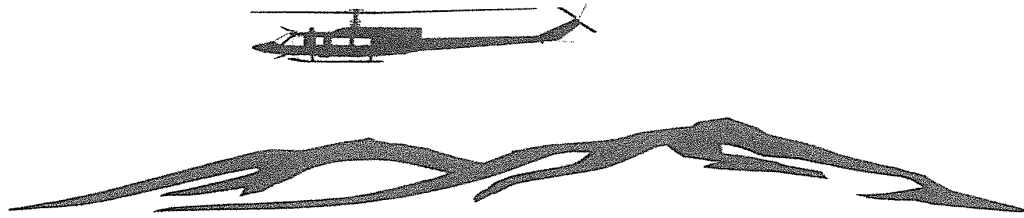

Dear Commissioners:

Thank you for your consideration regarding the conditional use permit for our private heliport and storage hangar. I was told that your team would be reviewing material this week prior to the hearing, and wanted to provide you a brief background on our company mission and family to help you understand why this project is so important to us and such an integral part of our dream.

My husband and his family moved to El Dorado County in 1980. The Glass family is 26 members strong, and they have lived in El Dorado County and worked in the community for over 30 years. After we married and had our first daughter (we have two beautiful girls) my husband and I opened our own private tree company Dave's Tree Works. We have operated this business successfully for over 12 years, providing emergency hazardous tree work and property clearing for fire protection to the local community.

It is now our dream to open a new chapter with a newly operating helicopter company Northern X-Treme Helicopters in El Dorado County. We are in the final stage of building our helicopter and plan to be operational this year to offer aerial fire support immediately for Cal Fire and the State of California.


In general it is the Mission Statement of Northern Extreme Helicopters to provide environmentally sound, safe, reliable, and innovative aerial support regardless of terrain or geographic location. We will primarily provide Fire Support, Erosion Control, Emergency Frost Control, External Load/Long Line Operations, Government Contracting, Agricultural Seeding, and Power Line Patrols.

The hearing on August 23<sup>rd</sup> is integral to our ability to operate. We need to have a secure location, that is private from the community, to safely store our helicopter and fire gear. We

have taken measures to ensure public safety by fencing all entry to our private property. We have attached to the fence all required signs alerting the public that our hangar is private and not for public use, and we have established safe areas and restrictions during operations.

With the support of you and our local community we will be able to launch this season in time for operations as planned. We thank you for your consideration and look forward to seeing you at next week's hearing to finalize our project dreams.
