



**RESOLUTION NO.**

**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**WHEREAS**, appointed department heads receive a higher level of compensation, either in base salary compensation or in other forms of benefits, due to the nature of being an ‘at-will’ employee and the increased responsibility associated with the position; and

**WHEREAS**, the positions identified as Assistant Chief Administrative Officer, Deputy Chief Administrative Officer, Assistant Director of Administration and Finance, Assistant Director of Community Development, Chief Assistant County Counsel, Chief Assistant Director of Health and Human Services Agency, Mental Health Director and Chief Budget Officer, in addition to the Undersheriff and the Public Health Officer, have been provided the same level of benefits as Board appointed, ‘at-will’ department heads, while retaining civil service protection; and

**WHEREAS**, although pursuant to County Charter the Undersheriff has return rights, the Undersheriff is an at-will position that works at the pleasure of the Sheriff; and

**WHEREAS**, pursuant to the California Health and Safety Code Section 101000 of Chapter 1 of Part 3 of Division 101, which states, “each board of supervisors shall appoint a health officer who is a county officer;” and

**WHEREAS**, on September 26, 2017 the Board approved changing the benefit level of all of these positions, with the exception of Undersheriff and the Public Health Officer, from Unrepresented Department Heads (UD) to Unrepresented Management (UM); and

**WHEREAS**, due to their unrepresented status, the Board of Supervisors may establish the compensation for these positions by resolution pursuant to Section 503 of the County Charter; and

**NOW, THEREFORE, BE IT RESOLVED**, the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed.

**BE IT FURTHER RESOLVED** that the Board of Supervisors of the County of El Dorado does hereby modify the benefit level, denoted by union code, for the following classifications, effective the first pay period following adoption, as set forth below:
