FIRST AMENDMENT TO SOLID WASTE SERVICES AGREEMENT #6917

THIS FIRST AMENDMENT to that Solid Waste Services Agreement #6917 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Tahoe Truckee Sierra Disposal, Inc., a corporation duly qualified to conduct business in the State of California, whose principal place of business is 645 West Lake Boulevard Suite 5, Tahoe City, California, 96145 (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide the collection, transportation, processing, and disposal of solid waste and recyclable materials for the County's Environmental Services Department pursuant to Solid Waste Services Agreement #6917, dated September 29, 2015, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date of September 29, 2022 for three (3) additional years, amending **SECTION 11, Term**;

WHEREAS, the parties hereto desire to fully-replace specific Articles and add new Articles to include updated contract provisions;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Solid Waste Services Agreement #6917 on the following terms and conditions:

- I. **SECTION 11, Term**, of the Agreement is amended in its entirety to read as follows:

SECTION 11

Term: This Agreement shall become effective when fully executed by the parties hereto and shall cover the period of September 29, 2015 through September 28, 2025, as amended.

- II. **The following Articles of the Agreement are fully replaced in their entirety to read as follows**

SECTION 28(I)

Notices: All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to County shall be in duplicate and addressed as follows:

SECTION 28(Q)

Contract Administrator: The County Officer or employee with responsibility for administering this Agreement is Jeffrey Warren, Environmental Management Department Director, or successor.

III. The following Articles of the Agreement are added to read as follows:

SECTION 28, U

Electronic Signatures: Each party agrees that the electronic signatures, whether digital or encrypted, of the parties included in this Agreement, are intended to authenticate this writing and to have the same force and effect as manual signatures. Electronic Signature means any electronic visual symbol or signature attached to or logically associated with a record and executed and adopted by a party with the intent to sign such record, including facsimile or email electronic signatures, pursuant to the California Uniform Electronic Transactions Act (Cal. Civ. Code §§ 1633.1 to 1633.17) as amended from time to time.

Except as herein amended, all other parts and sections of Solid Waste Services Agreement #6917 shall remain unchanged and in full force and effect.
