James Abram, Commission Chair: On January 1st, the new regulations for Welfare Institution Code [5604.2] needed to be applied to our Bylaws, related to Proposition 1, Senate Bill 326.

Meredith Zanardi, MHSA Program Coordinator: Process is to continue forward after the Commission votes to Approve as drafted, to bring it forward to County Counsel before being finally Approved by the Board of Supervisors. If for any reason there are additional changes required by those offices, this item will be bought back to the Commission for additional approval.

James Abram, Commission Chair: Suggests article-five "Commission Body" changed to "Commission Membership".

Dr. Stephen Clavere, Commissioner: Suggests additional language added to article-four from [Welfare Institution Code] 5604.2; after "review and evaluate the community's behavioral health needs, services, facilities, and special problems", add "In any facility within the county or jurisdiction where mental health or substance abuse evaluations or services are being provided".

Dr. Stephen Clavere, Commissioner: Suggests additional language added to article-five from [Welfare Institution Code] 5963, subparagraph 45963.2; after "Behavioral Health to conduct a public hearing on the draft integrated plan and updates by the close of thirty-day comment period required", add "and make substantive recommendations to the local mental health agency, local substance abuse disorder agency or local behavioral health agency as applicable for revision".

James Abram, Commission Chair: Requests County Counsel review ADA guidance and advise additional language that may be appropriate to add to the Commission bylaws.

James Abram, Commission Chair: Requests County Counsel's advise on maintaining language crossed out under article-eight item-two, regarding members on an approved leave of absence not counting towards establishing a quorum.

Dr. Stephen Clavere, Commissioner: In accordance with changes to article-ten to eliminate standing committees as part of bylaws, suggests removing from last sentence "both standing and ad hoc".
