The presentation by the Hemp Working Committee, Commissioner Bolster, Commissioner Draper, and Lexi Boeger updated the Commission with a Concept for Industrial Hemp allowing five producers to grow Hemp for the 2023 and 2024 growing season. The Commission felt that they could support forwarding this information to the Board of Supervisors requesting a Concept review allowing a two year test program. Commissioner Draper made a motion, seconded by Commissioner Bolster to send the Industrial Hemp Pilot Program Concept to the Board of Supervisors for their consideration for a two year test ordinance.
