

My name is Bonnie H. Rich. I am a 32+ year resident of El Dorado County and a 25+ year resident of Sand Ridge Road in El Dorado. I attended the Sand Fire benefit on Friday, August 22, 2014 to support my friends and neighbors that were victims of this fire.

When I left the event held at the fairgrounds, I found the attached flyer on the windshield of my vehicle.

This letter contains a message urging attendance at today's meeting.

I am disappointed that my personal property was violated in an attempt to put forth a political agenda at an event that was solely intended to assist victims of a catastrophic event in my county. The Sand Fire benefit was not intended to be used by individual(s) or organization(s) to further a political message of any kind.

This action could have caused further damage in ways I do not have time to express in this email.

Having said that, this flyer is not signed by any organization or person. Who is "we" as stated in this flyer? Who are these "friends" and "neighbors" claiming to help prevent catastrophic wild fires and increase our water supply?

Shame on the person(s) who did this! I am hyper sensitive to anyone touching my personal property as I was recently a victim of auto burglary in my county which resulted in life altering events. I am appalled and disgusted by anyone utilizing an event intended SOLELY to assist victims of mass losses, to further a political agenda....however well intended it may be.

Was an ordinance violated by this action? I clear my own property with my own efforts because it is the right and responsible thing to do. I don't apply for grant money to keep my eighty acres defensible around my dwellings.

I certainly hope this is not an effort of any fire safe council that may apply for title iii funding (or any other funding). The flyer isn't signed, so I'll assume that it was not an irresponsible action on their part.

I have much more I could and want to say. I may attend the meeting, but suffer from a herniated cervical disc that prevents me from sitting for long periods of time.

Please share this with the public during public comment.

There are more appropriate forums and venues to communicate these sort of matters.

As far as I am concerned,

this flyer was put out by incompetent, inconsiderate, and cowardly individual(s).

Who ever you are, you are not my neighbor or friend, and your sentiments do not represent mine....at least not in the manner it was delivered.

I would like to know if this action was done within the law. Was an ordinance violated? If any further damage was done to my vehicle who is responsible?
