River Recreation Opportunities in El Dorado County*

WHEREAS, El Dorado County provides recreation opportunities and facilities that include parks, trails, river and resource based recreation areas for the health and welfare of El Dorado County residents and visitors; and,


WHEREAS, the El Dorado County Parks and Trails Division is responsible for the River Management Program, regulating the whitewater recreation activities on the 20.7 mile segment of the South Fork of the American River below Chili Bar Dam in coordination with the agencies and organizations that share oversight and a commitment to maintain our river resources for the enjoyment of the public; and,

WHEREAS, community volunteers assist the County in efforts to preserve the river corridor's environmental resources, protect the area's rural character and maintain a quality whitewater boating experience; and,

WHEREAS, in 2017, dedicated river volunteers donated over 700 hours of service, supporting the El Dorado County River Management Program with river clean-up projects and through their participation in meetings to plan improvement projects and to provide their valuable knowledge of the river and to advocate in support of the needs and requests of the community.

NOW, THEREFORE, BE IT PROCLAIMED, that the Board of Supervisors of the County of El Dorado does hereby recognize and extend its gratitude to the community volunteers who devote their time, energy and talent to support the County in efforts to protect the South Fork of the American River while maintaining the whitewater and river recreational opportunities in El Dorado County.




