

FIRST AMENDMENT TO AGREEMENT FOR SERVICES #6552

THIS FIRST AMENDMENT to that Agreement for Services #6552 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Cordico Psychological Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 2377 Gold Meadow Way, Suite 100, Gold River, California 95670 (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide pre-employment psychological and post-employment "fitness for duty" psychological examinations for the Sheriff's Office, Office of the District Attorney, and for the Probation Department pursuant to Agreement for Services #6552, dated May 24, 2022, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to revise the rate for Pre-employment psychological screening, including psychological testing, individual clinical interview, and written report of results, by adding a second line in paragraph two, increasing the total not to exceed amount in paragraph three, and revising the address for the Sheriff's Office in paragraph five of **ARTICLE III, Compensation**;

WHEREAS, the parties hereto desire to update the Notice to Parties, amending **ARTICLE XIII, Notice to Parties**;

WHEREAS, the parties hereto desire to update the Contract Administrator, replacing the entire paragraph in **ARTICLE XXVI, Contract Administrator**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

ARTICLE III

Compensation for Services, subparagraph A of the second paragraph of the Agreement is amended to read as follows:

For the purposes of this Agreement, the billing rate shall be the following:

- A. Pre-employment psychological screening, including psychological testing, individual clinical interview, and written report of results at \$400.00 per candidate. Beginning January 1, 2023, this billing rate will increase to \$460.00 per candidate.

The third paragraph is amended to read as follows:

Total amount of this Agreement shall not exceed \$125,000.

The fifth paragraph is amended to read as follows:

Except as herein amended, all other parts and sections of Agreement for Services #6552 shall remain unchanged and in full force and effect.
