Dear Supervisor Thomas,

I attempted to send an email earlier today, but I am not sure if it transmitted; so, I am making a second effort. By the way, I sent you an email in early February (slightly more than a month ago), but have yet to receive a reply. I am a constituent (Camino), and I voted for you. To say that I am disappointed in your posture vis-à-vis the HRC is an understatement. I have generally viewed you as a moderately conservative leader, one not driven by ideology but rather by principle. Frankly, I fear that your position on this issue belies that image.

Before I get to the specifics of my argument I ask you to consider the words of my former boss, President Jimmy Carter, who has pointed out that "America did not invent human rights. In a very real sense, it is the other way around." That is a powerful sentiment, and it is extremely relevant to the current debate.

My key points are as follows:

- Human rights are under assault around the globe. El Dorado County should be a bulwark against such assaults, not an enabler;
- There have been a number of human rights abuses in El Dorado County over the past few years; citizens should have an <u>official</u> channel through which to voice concerns about such abuses;
- Protection of human rights is a legitimate and necessary function of government; shifting that responsibility to a non-profit entity is a fig leaf that doesn't provide the cover or protection you think it will;
- We should want to make El Dorado County a welcoming community to all people, not a hostile one;

• This is a time for political courage, not bowing to extremists' agendas.

I truly hope you and your colleagues will consider my view with the same seriousness with which it is offered.

Dear Board of Supervisors,

Please do not disband the Human Rights Commission in El Dorado County. Please delay the second reading and hearing so the public has sufficient time to understand the magnitude of your proposed action.

Disbanding a human rights commission that takes the time to listen to marginalized and vulnerable members of our county share their experiences of suffering, intimidation and disquieting isolation is a violation of human decency

I have only been on the commission for a short time however, in that short time I have witnessed people experiencing life in the elements without shelter share the unnerving truth of how demoralizing and dependent their lives became in El Dorado County after deteriorating healthcare. Three people gave testimony at the EDC HRC Community Homeless Forum who experienced injury/illness, which led to inability to work, which led to inability to pay rent, which led to agency dependence, which led to more demoralizing failure to maintain independence. Don't you want healthy communities' commissioners? My supervisor, John Hidahl runs a healthy community series of public meetings. He addressed mental health, and access to healthcare. A young lgbtq student shared her feelings of being stigmatized and isolated on top of mental health concerns. He is compassionate and concerned about the community, why are you not? Social change is not always political (think of acceptance of child labor at the turn of the century or chattel slavery in the antebellum and Jim Crow USA), not political yet people fought for it to continue, not political but in need of change)

Sadly, affordable housing in El Dorado county, especially for those without an income is challenging and often unattainable for those impacted by poverty, pain and depression or other mental health challenges. Where is your sympathy, compassion, and willingness as local leaders to acknowledge the **weakest and most stigmatized among** us. This includes unhoused veterans, children who are homeless (yes there is a segment of the unhoused population who are children moving from house to house and couch to couch (statistics from Housing El Dorado and EDCO) fire victims unable to access resources, people with mental health issues, those experiencing substance use disorders, those with stigmatized sexual and gender orientations, women suffering from domestic violence, people who are not white and experience racism, people who are unable to access clean water and air, people who follow non-Christian religions, those with food insecurity and so on and so on. Why do you want to turn a blind eye and reframe their suffering as political? Yes they need resources but not for political reasons, for quality of life reasons and human rights reasons.

As leaders you do not need to like those who are different from you, but you are expected to represent their best interests. How can you as leaders represent their best interests if you do not want to look at the problem and make moves to fix it. Disbanding the commission is denial on your part and appears as an effort to marginalize these humans

further. It is your responsibility to look out for us humans, not dehumanize the weak and least able to defend themselves, and turn a blind eye. I witnessed racism in my town of El Dorado Hills and accepted the sanctions the CIF imposed on my local high school for not stopping and acknowledging racism when it happened. The HRC had the EDCO representatives speak to the commission as they acknowledged the fact that the incident was not acknowledged in real time and made amends to change the way the school addresses racism. Racism does exist in the county and should not be upheld. I have actually worked with the Oakridge high school students in creating and hanging an art exhibit at the K-12 gallery (I am an artist and licensed professional clinical counselor) regarding expression of mental health concerns and accompanied them down to the state capitol , along with their teachers and principal to meet with their representatives and share their mental health concerns and learn how government can help, civic engagement is something that can me learned (Dahle and Kiley at the time). I want to empower people to speak their truth, not dismiss it in fear of the opinions of others.

Allowing people in the community who are suffering a space to be seen, heard, and shared with the public under the watchful eye of local government in a respectful manner is not activism. How dare you Ms Parlin accuse the commission of such. . Also Commissioners Thomas, Parlin and Turnboo, you all represent districts that are less diverse than districts 1 nd 5. I invite you to think about your exposure to and understanding of diversity and how that impacts your votes. I am very disturbed you removed the required Implicit Bias training as that is designed to reduce discrimination. Do you want discrimination to continue?

I know of all the procedural issues that were not followed in your attempts to disband this commission, there are many submitted to this agenda item and I have read most of them. I agree with them and will be monitoring how that lack of attention to legal protocol was violated by the Board of Supervisors.

I was shocked by the lead person trying to disband the commission, Ms Purlins' bullish banter during the BOS meeting of 3/7 and her walking out of the meeting when she did not win a vote to be on an ad hoc committee. She looked like a petulant child. That is not good stewardship as a county leader and it was witnessed by the community and it is on video. Maybe members of the public are following her decorum when they name call and bully people who are different from them. Think about that.

I can say much more about how horrible disbanding the commission is but I will close this letter hoping you hear my plea to be more compassionate.

The EDC Board of Supervisors' (BOS) establishment of a county Human Rights Commission in 2018 is a milestone to be lauded and built upon, not disbanded.

In 1961, the California Legislature adopted provisions promoting the establishment of commissions in California counties "to foster peaceful relations in the interest of preserving the public peace among citizens of different races, religions and national origins," including authorizing the expenditure of public funds to attain these objectives (GC 50260, 50261 as enacted). By amendment in 2001, the Legislature specifically provided for the creation of county commissions on human relations, and included precise responsibilities and duties (GC 50262-50265).

Over 60 years after enactment of the initial statute, the EDC Human Rights Commission was created by the BOS in only 2018, it is fewer than 5 years old.

To learn that a member of the BOS has called the Commission "a complete failure" is like a parent blaming a child who is malnourished for the parent's failure to feed them. When the same BOS member stated that the member did not envision the Board "allocating... the enormous resources... needed to make the (Commission successful)" and "We just aren't doing it well," is tantamount to an admission the child was produced, then abandoned. It is reported that the same BOS member thereafter moved to "disband the Human Rights Commission" and instead appoint 2 BOS members "to participate on the Bridging Divides-El Dorado group." The motion was seconded.

Further, the child is almost 5 and is becoming a problem: It is becoming "activist."

The proposed referral to a non-profit agency, i.e., "adopting out" the child is inappropriate. The non-profit referred to, Bridging Divides-El Dorado (newly inaugurated in the Fall of 2022) is a committee of its parent non-profit the El Dorado Community Foundation, which exists "for charitable and educational activities" per its website. While extremely significant, the purposes of the Foundation and of the EDC Human Rights Commission per the Government Code and EDC ordinance, are not the same.

The Human Rights Commission is charged by law with taking "actions": to conduct studies, inquire into incidents of tension and conflict, to conduct and recommend educational programs, to hold conferences and public meetings, to issue publications and reports, to enlist the cooperation and participation of people, to encourage and stimulate agencies within the jurisdiction of the local governing body to take action. (GC 59264, 50265.)

The work of the EDC Human Rights Commission is vital. It is undisputed that our society is divided, as too often reflected by untruths, hate speech, and violence. Efforts to understand and ensure public peace, health, safety, and the general welfare are necessary.

As such, the BOS must:

- 1. Provide accurate documentation of its meetings;
- 2. Ensure transparency by stating facts and bases for positions and decisions;
- Respond as required to complaints made including concerning its review of the EDC Human Rights Commission;
- 4. Support the work of the EDC Human Rights Commission;
- 5. Provide funding in furtherance of the EDC Human Rights Commission's responsibilities and duties;
- 6. Fill vacancies in furtherance thereof; and
- 7. Take appropriate action on consideration of recommendations of the EDC Human Rights Commission.

Dear El Dorado County Board of Supervisors:

I watched the January 24 BOS meeting and was dismayed to witness first, Supervisor Lori Parlin disparage the work of the Human Rights Commission, and then later put forward a motion to disband the Human Rights Commission altogether. The BOS responded by voting 3-2 to dissolve the Human Rights Commission. I strongly believe that disbanding the HRC is premature and unwise. I believe the HRC should continue in its mission to "promote tolerance and mutual respect among all persons, and to foster peaceful relations in the interest of preserving the public peace among residents of different races, religions, national origins, and the other characteristics listed in Government Code section 11135."

- she has a hard time knowing what the HRC is doing; and that [she] can't "personally articulate what the commission has done to help the Board and county"
- the HRC lacks proper boundaries and doesn't know how to be in their "lane"
- the HRC doesn't have the proper resources to do its job.

Please allow me to address Supervisor Parlin's points:

First, contrary to Parlin's belief that the commission hasn't really achieved much during its tenure, the HRC has accomplished quite a bit, especially for a young organization launching itself during the onset of a pandemic. Since July 2018, the HRC has:

- established a Purpose, Vision Statement, and by-laws
- held a Public Human Rights forum
- developed a strategic plan
- created a report on "Implicit Bias"
- met with county educators to discuss instances of bullying and discrimination at school sites and at the district level

• hosted Civil Rights Attorney Mark Merin to speak on the difference between Civil Rights and Human Rights

- held a forum on the homeless in El Dorado County,
- developed a Speaker series on Human Rights
- enlisted members to attend CA Attorney General Rob Bonta's webinar on Hatred Against the AAPI Community

Second, if the HRC lacks boundaries or proper knowledge of county governance procedures, then I believe it is the BOS's responsibility to identify and provide clear guidance to the HRC (and frankly to all county commissions) so that it can effectively operate without violating any laws. (Interestingly enough,

when the HRC requested funding for Implicit Bias and Good Governance Training for its commissioners, that request was denied by the BOS.) Rather than dismantle the HRC, both the HRC and the BOS should work together to resolve their current disconnect. To abandon the commission altogether is not good governance and is to ignore the very real and dire issues that face our county with regards to discrimination, equity issues, racism, and sexism.

Third, Supervisor Parlin states that the HRC doesn't have proper resources to do its job. True, it may be that the commission doesn't have access to county funding, but it's important to note that the commission has done an admirable job in spite of being underfunded. Though four years of outreach and education, much of it during a pandemic, they've established a valuable network of groups and individuals who support their cause and their work. To disband the HRS could quite likely sever those important community ties.

Unfortunately, it appears that during its brief tenure the HRC has been stymied rather than supported by the BOS. Less than two years after the commissioners were appointed, Supervisor Parlin proposed that the HRC either be disbanded or put on hiatus until a formal process had been created for bringing up issues on their agenda. Such extreme proposals seem to me unwarranted. Why put the HRC on hiatus? Instead, why not have the Board actually lend a helping hand? As a new organization just getting its sealegs, wise guidance from the Board seems to me imperative.

Then, on December 8, 2020, the Board set up further roadblocks for the HRC by redlining one of its most important responsibilities, deleting the following bylaw:

C. To inquire into incidents of tension and conflict among or between people, including people subject to prejudice and discrimination due to race, religious creed, color, national origin, ancestry, physical disability, mental disability, marital status, gender, sexual orientation, socioeconomic status, civic interest, or any other factors, and to take action by means of conciliation, conference and persuasion to alleviate those tensions and conflict.

This gutting of the language that represents the very heart of the Human Rights Commission's mission seems to be an act of bad faith, designed to weaken and erode the organization's integrity and ability to do the work of upholding equality, fairness, safety, and respect.

Furthermore, Supervisor Parlin suggested that the concerns of the Human Rights Commission are best served by a non-profit, specifically recommending that Bridging Divides El Dorado as the best organization to address these concerns. This was a preposterous and presumptuous suggestion on Parlin's part as she had not consulted with Bridging Divides to see if it would even be willing to take on the work of the HCR. In the same vein, Parlin did not consult or discuss with the Human Rights Commission her intention to disband the organization. No matter her claims otherwise, her actions are disrespectful, revealing a basic disregard for the effort and work undertaken by the HCR and for the tenets of due process.

I would like to echo Supervisor John Hidahl's comments when he said that the establishment of a healthy commission requires several stages: forming, storming, norming, and then high-performing. It takes time for a county commission to establish itself and fully engage with the community. The work involves outreach, education, publicity, and public forums. Establishing a robust Human Rights Commission is a long-term commitment because human rights *ARE* long-term. And as a Board, when you signed the Human Rights Commission into existence, you were making that commitment to the preservation of human rights in our county. Give the HRC a chance by offering them the proper support and guidance. Don't shut this commission down and undo all the good work that has already been accomplished.

Subject Matter: Formal Complaint: El Dorado County Board of Supervisors Procedure and Process for Disbanding the El Dorado County Human Rights Commission (HRC).

I am submitting this complaint because I believe there has been a problem with the process and procedure that the El Dorado County Board of Supervisors have taken to disband the County HRC which does not allow for An open, transparent public meeting process:

- · Access by the public and constituents for participation
- Notification to the public
- Notification to appointees that are being removed from governmental position

Each Human Rights Commissioner is appointed by their District Supervisor. Two Supervisors are appointed and sit on the HRC.

Issue 1: Ending of Human Rights Commission Meetings Lack of transparency, lack of openness, Authority for ending the meetings, Brown Act Violation ?

The last HRC meeting was November 28, 2022. The HRC commission meetings did not resume after the HRC made its year end presentation to the County Board of Supervisors which also included the Commission's proposed 2023 work plan.

There was never an agendized item, public meeting, or public vote by the Supervisors to end a County Commission meeting schedule. A single supervisor requested to the HRC Chair that the commission no longer meet. No other commissioners or the public was notified and the meetings ceased to continue.

Issue 2: January 24, 2023 Meeting arguments against the Human Rights Commission, Elected official inability to participate

The arguments made against the actions of the Human Rights Commission are all documented guidelines on how the commission should operate based on Ordinances which the Board of Supervisors have adopted and even amended over the last several years:

3-20-18 Ordinance 5081(Initial Parameters of HRC)

3-19-19 Ordinance 5099 adopted.pdf (New 2 year evaluation established)

4-9-19 Bylaws - approved

9-29-20 Amended Draft Bylaws

12-8-20 Item - Ordinance 5134 (No funding is allocated for HRC training)

One argument is made that there are not enough Supervisors on the Commission. The Board of Supervisors have the ability to appoint Supervisors. One Supervisor space is vacant on the Commission. The newly elected Supervisor volunteered and requested to be on the Commission. Her request was not entertained

Issue 3: Lack of transparency and openness of an agenda item. Action taken not identified in the agenda. Brown Act Violation?

The January 24, 2023 agenda and meeting description: Item 37 37. 23-0128 Clerk of the Board recommending the Board discuss the purpose, mission and membership of the El Dorado County Human Rights Commission and provide direction to staff on how to proceed.

Action taken - A motion was made, seconded, and approved to direct staff to return to the Board within 60 days with an item to disband the Human Rights Commission.

This agenda item did not alert the public that the Human Rights Commission had the potential to be disbanded. This is an action which will remove commissioners from their public appointment. The Commissioners were not notified to attend.

A cure and correct letter was submitted to the El Dorado County Board of Supervisors which was addressed in closed session 3/7/2023. No report out was made.

Issue 4: Upcoming Procedure - Dissolution of the Human Rights Commission by Ordinance The first ordinance reading will be waived on 3/14. The second reading and final passage of the ordinance is currently scheduled for 3/21.

Problems with notification. If this is an ordinance, shouldn't there be 1) publication of the ordinance, 2) a public hearing before the vote to decide on accepting or rejecting the ordinance.

With the publication of the ordinance, should that include all areas of the County from South Lake Tahoe to El Dorado Hills? Does this need to be in print media?

With a public hearing isn't there a mandated time that the public needs to be noticed before their is a public hearing? How should this notice occur?

This is a decision to remove public appointees from a Brown Act Commission. The commissioners need to be notified to attend the meeting and each allowed to provide testimony. The commissioners should be given time to speak, separately from public comments.

With the procedure and process that has been done up to this point, I am concerned that the due process for the hearing may not be followed which will again limit the public's ability to have access and participate in what should be open, public meetings per the government code.

Dear County Supervisors;

I have previously written to the County Board of Supervisors (BOS) regarding the potential actions to eliminate Implicit Bias training, and now to disband the Human Rights Commission. Both are highly disturbing given facts which show a long history of Human Rights Violations in this County as well as a disregard when there are infringements on personal rights if the victim is a person of color, LGBTQ, or a woman. However, I can't help but note that these harmful BOS actions seem to be originating from one Board Member in particular, and sadly that is Lori Parlin.

I find this very disappointing because Ms. Parlin campaigned on responsible land use and retaining the rural nature of El Dorado County. This appealed to many voters of District 4 (and also to people like me in District 3). Ms. Parlin was also registered as "No Party Preference" at the time and was celebrated for that with much bi-partisan support. As a result, she was elected in November 2018, and began her first term of office in January 2019.

Perhaps if we had learned what Lori Parlin thinks about human rights, she would not have been elected. Regardless, the following actions by her are alarming when taken together:

1. The HRC had been established almost two years. Yet on 30 June 2020, Parlin suggested changing the way the HRC would be allowed to operate and also made her first suggestion that the HRC be disbanded.

2. On 24 January 2023, with Novasel no longer serving on the Commission, Parlin forged ahead with a suggestion to dismantle the HRC, even though the discussion *was not on the agenda*. Supervisor Brook Laine of District 5 suggested that she could take Novasel's place and sit on that commission. This suggestion was ignored.

3. Now Supervisor Parlin states that that the HRC is too activist. Yet during the same discussion she claims that the HRC does not accomplish anything. How can an organization can be taking too much action, and taking no action at the same time? It can't be both. If the BOS is to support Supervisor Parlin, it needs to be more honest and specific as to what is wrong with the HRC.

From my perspective, the HRC has been doing good work that falls within their mandate, including sponsoring educational events. Those events were well-attended by the public. As with all organizations, activity stopped during the COVID shut down. But when they once again began meeting regularly and working within their roles with the oversight of two members of the BOS.

Taking the stance that our county does not need a Human Rights Commission is willful ignorance, as we are dealing with issues of hate crimes and hateful speech ongoing and the consequences to our

schools, places of worship and businesses. This County is already known throughout the country as the one with the Proud Boy Santa and a man hanging from a noose downtown. Why would any casual observer be surprised that a commission to help protect Human Rights would also be abolished?

Thank you for your time and attention, and I urge you to think carefully about the effect that disbanding the HRC would have on citizens of this county who are most impacted, as well as the image of El Dorado County that is being projected throughout the country. This is the time for the BOS to make it clear where you stand with respect to Human Rights.



March 1, 2023

On the morning of March 1, 2020, members of St. Stephen's Lutheran Church and the surrounding community were stunned to see hate speech and explicit and racist symbols spray painted on our sign on the corner of Olson and El Dorado Hills Blvd.

Photos were taken and Property Manager Gary Franzen went down to the point, meeting with a CSD worker who was diligently working to clean up the mess. He said that many sites in El Dorado Hills had been tagged, including park signs and signs for other businesses.

St. Stephen's was contacted within a few hours by the FBI, and Agent Robert Tripp came by the church to interview Pastor Franzen and Gary Franzen. According to Agent Tripp, the FBI takes these incidents very seriously. It is not just "kids out making trouble." It is a federal crime and the community has been harmed by the presence of white supremacy and the threat of violence.

A member of this congregation suffered the trauma of the Holocaust. She was just five years old when the Nazis came in the night and took her father. She starved, nearly died and witnessed atrocities and hatred that were imaginable. When she saw the image of the Swastika on our church sign, she was triggered and retraumatized. Each time she witnesses or hears hate speech, she ever more resolved that racist violence should not take place anywhere in America and especially not in the home town of herself and that of her extended family: El Dorado Hills.

I was encouraged by the conversation with Agent Robert Tripp. He expressed distress and concern about white supremacy, systemic racism, police misconduct and affirmed our efforts to talk openly about racism with our Racial Healing Circles. Though we wished this had never happened, we do see that our work for healing and justice in this world is truly "in our own backyard."

The Human Rights Commission did nothing but promote peaceful living in our County. They did nothing to dishonor anyone, and sought safety and security for all of our residents.

Though a few of our residents would like nothing more than to establish a "Whites Only" County, I make the assumption that you, the Board of Supervisors, do not represent or consider yourselves part of that number. Your action to dismantle the Human Rights Commission puzzles and confuses me and the members of my congregation. We are disappointed in your decision to obstruct to good work that our law abiding citizens are trying to do on your behalf.

Furthermore, the decision to eliminate implicit bias training casts doubt on your credibility as earnest leaders.

EI Dorado County BOS created the Human Rights Commission (HRC) in March 2018 in response to increased bullying on school campuses and now, on Jan. 24, 2023, BOS Supervisors Parlin, Turnboo and Thomas voted to abolish HRC. Supervisors Laine and Hidahl voted to retain the HRC.

As stated in the EDC Board, Committee & Commission Handbook, the "commissions serve a vital role in County government by gathering and analyzing public input and recommending options to the Board... serve in a fact-finding or advisory role... assist the Board with the varied duties and responsibilities of local government and to encourage citizen involvement, expertise and participation ."

Under the 2018 ORDINANCE NO. 5081, the HRC's purpose is to promote tolerance and mutual respect among all persons, and to foster peaceful relations in the interest of preserving the public peace among residents of different races, religions, national origins, and other characteristics..initial responsibilities were to "foster mutual respect and understanding...make any studies in any field of human relationships...inquire into incidents of tension and conflict...conduct and recommend any educational programs... hold public meetings in the interest of the constructive resolution of tensions, prejudice, and discrimination among or between groups of people, including people subject to prejudice and discrimination due to race, creed, color, national origin, ancestry, physical disability, mental disability, marital status, gender, sexual orientation, socioeconomic status, civic interest, or any other factors".

No funding was provided to this Commission, and a 2020 request for funding for a training was denied by the BOS.

In 2020, the BOS reduced the duties of the commission by deleting "inquire into incidents of tension and conflict.." from the ordinance.

The BOS has a huge workload. As an example, 44 items appeared on the Jan. 24, 2023 agenda requiring Board decisions. The BOS would be hard pressed to decide on these matters if it could not rely on commissions, committees and staff to research and present data to the BOS. Commissions are bound by County ordinance to be transparent, unbiased and thorough when advising the BOS. Private organizations are bound by no such rules, and the suggestion by Spvsr. Parlin that a private organization such as Bridging Divide should be given the task of preserving the public peace & of fostering peaceful relations among residents of different races, religions & national origins is disingenuous and misguided. Private organizations have no statutory advisory role or accountability to the County, and therefore have no right to be heard & are less likely to ever make it onto the BOS calendar.

Why would Spvrs. Parlin, Turnboo and Thomas NOT want the BOS to be provided with assistance in tackling these issues? Are they against basic human rights? The concepts which fall under human rights are broad: right to freedom, equality, life, liberty, security, property, expression, participation in government etc. These are stated in the 1948 Universal Declaration of Human Rights, and various US documents i.e., Bill of Rights, Declaration of Independence, Constitution etc.

These abstract terms mean nothing if not realized by concrete measures- one cannot have security and life if there is no shelter, food or clean water and disease prevention measures which benefit the entire population, not just the wealthy. Human rights are not just being civil to one another, it is ensuring that humans have the means to lead a life in dignity. Entrusting this task to a non-governmental agency which does not have the means to enact broad societal changes or enforce the law will not work. As an example, Federal troops enforced school desegregationnot the good-hearted non-profits in Georgia.

Spvsr. Parlin held forth at the January 24th BOS with vague unsubstantiated claims that HRC had done nothing since its' inception (not true, Human Rights Day Proclamation 2020; Speaker Series developed 2022, Public Human Rights Forums were held July, 2019; Forum: "A Day in the Life of a Homeless Person" held June 13, 2022; School Board speakers at April 2022 mtg re bullying, discrimination; civil rights attorney speakers in May 2022; Speaker Series planned for 2023;).

Of note, the BOS placed HRC on a hiatus 2020, and Covid restrictions hampered that group from meeting.

Also at the Jan. 24 meeting, Spvsr. Parlin complained that HRC had legally endangered the County by contacting the Miwok Tribe: in fact, Spvsr. Hidahl proposed this.

Spvsr. Parlin complained about rotating members appointed each year and a lack of resources provided by the County: then why doesn't the County change the ordinance and bylaws and provide resources? Other commissions also have rotating members-are they being disbanded? Spvsr. Parlin referred to and criticized an HRC Work Plan during the meeting, but admitted she had not provided this plan to the BOS for prior review. She stated HRC "didn't stay in their lane", (the County) "could get in trouble if we don't put the rail" on HRC, has serious concerns about this and other commissions, but did not name them. What are the concerns, and why have those other commissions not also been disbanded?

If El Dorado County is truly interested in the advice and guidance that it can gain from commissions, then EDC BOS should be willing to support, train & guide these commissions so they can do the work.

And a time commitment to the mission is required. Human rights is not a short-term goal with an end product. Other CA counties and entities acknowledge that this is a perennial issue and have formed & supported HR Commissions: Sonoma (1993), Los Gatos, Humboldt, Marin, Los Angeles, to name a few. Will El Dorado County be lauded as the County that miraculously solved all human rights concerns, past and future? Or will El Dorado County be known as the County that denied its' residents government access to discuss human rights by disbanding the Commission. As Supervisor Hidahl said, committees need to be allowed time to evolve through, "forming, storming, norming, to high performing." I encourage the BOS to retain the Human Rights Commission. I recently read in the Mountain Democrat that the Board of Supervisors are considering disbanding the county's Human Rights Commission (HRC) (Feb. 8, 2023). In the article, Supervisor Parlin was noted as stating that the commission was struggling. She recommended that a non-profit such as Bridging Divides take on the humanitarian mission of the commission. As a long-time resident of the county living in district 3, I would like to offer a perspective on this issue.

First, I worked for a non-profit for 24 years in this county (PRIDE &Joy/Family Connections a program that served families with infants and toddlers with disabilities). We provided quality services and were dependent on El Dorado County Office of Education and a State Regional Center for stable funding and government code to guide our actions. The point being, it was a combination of a government agency which had finances and power to support the non-profit's services. I offer that the Human Rights Commission needs to continue as part of our county programs for stable financial support and code guidance.

Bridging Divides-El Dorado was raised as a possible alternative to the HRC, however Bridging Divides-El Dorado has a different mission than the Human Rights Commission: The mission of Bridging Divides – El Dorado is to provide resources and tools to build trust and respect, to depolarize challenging situations, to promote civil and cordial conversations, and to encourage collaboration for the well-being of all El Dorado County residents. We are available to assist any organization impartially and without bias. (www.bridgingdivides-eldorado.org)

As a community member I value the purpose of a HRC as stated in Ordinance 5081:

2.20.1101 The purpose of the Human Rights Commission is to promote tolerance and mutual respect among all persons, and to foster peaceful relations in the interest of preserving the public peace among residents of different races, religions, national origins, and the other characteristics listed in Government Code section 11135.

I have participated in an all-day workshop in April 2022 and a couple of online workshops through Bridging Divides. Members trained in community conversations may be of assistance in continuing the discussion of what is next for the HRC, rather than disbanding the 5 year-old commission.

You five supervisors, as elected officials in our county, are public servants, and we count on you to 'Do The Right Thing' for your constituents.

Are you serving the public, as you attempt to slam through the disbanding of the Human Rights Commission? Or are you serving some other political goal that the public, your voters, may not <u>vet</u> be aware of?

As I understand it, the goal of the HRC is to inform and educate the public about issues concerning many of us, including marginalized and vulnerable people. If the by-laws of the commission need fine-tuning, then we can do so. When there is so much divisiveness in our county and country these days, we need MORE understanding and open mindedness, not less.

I'd like to share an experience of an acquaintance of mine. My former co-worker, who is a young black man living in Sacramento County, had a side job as an Uber driver. Late one afternoon in 2022, he picked up a passenger at the Sacramento airport and drove him to his home in Placerville. While trying to figure out how to leave Placerville, a town he wasn't familiar with, a white man started following him in an aggressive manner. At a stop sign, the white man challenged him, asking what he was doing. After hearing that he had an Uber passenger he had dropped off and was now leaving Placerville, the white man said, "That's good, son. You don't want to be here after sundown." So essentially this white man was calling Placerville a 'sundown' town; (https://en.wikipedia.org/wiki/Sundown_town provides history of that term if you are not familiar).

To no surprise, my friend has NOT returned to El Dorado County but he has relayed his frightening experience to a number of people. And to no surprise, his telling of this shameful story does NOT present an image of El Dorado County that we residents can be proud of.

I urge the Board to consider negative impacts to our county from a decision to disband the HRC. As word spreads to potential visitors that EDC is NOT a safe nor friendly place for all persons, that may discourage visitors from coming here to visit wineries and restaurants, go sightseeing, go shopping or stay in a hotel. Surely the EDC business community is not in support of you impacting their businesses with a very bad image of EDC as unwelcoming and unsafe.

I urge you to Do The Right Thing - slow down this process - and keep the HRC.

I am deeply alarmed by the disbanding the Human Rights Commission of El Dorado County. Neither I nor the other commissioners were formally alerted to the complaints put forth by the El Dorado County Board of Supervisors. The completed work of the commission was presented to the BOS on November 8, 2022, and responded to by the supervisors with praise and no complaints of wrongdoing. How did this change?

It should be noted that on or around the date of January 27th, 2023, the Chair of the El Dorado County Board of Supervisors presented an informal email letter to the El Dorado County Human Rights Commissioners thanking them for their service and reporting that the majority of supervisors had voted to disband the commission. While generalities were offered, there was no factual details given for disbanding, nor invitation for an opportunity to respond. The mention was made that a non-government organization, "Bridging-the-Divide," may better conduct the commission's mission.

Other than the above, the HRC have not received a formal letter outlining grievances that have been put forth by the BOS. Not only is this disrespectful, but unseemly for a county governing body to conduct business in this manner. Before accusing the human rights commissioners of wrongdoing, respectful communication should be made to present grievances in order for commissioners to respond. The human rights values of fairness, dignity, equality, and respect seem to be overlooked in this process of elimination.

As a retired Santa Clara County Public Employee who has worked in criminal justice, mental health, office of the public guardian, superior court, and other human service sectors, I have many years of experience providing services to disadvantaged and marginalized communities. I feel personally insulted for not being consulted, receiving secondhand hearsay, and having to check the public archives for accusations and judgements made against me as a Human Rights Commissioner for El Dorado County.

Human Rights to protect human interests (everyone's interests), is ongoing work and a constant reminder that we are all equal. It is a guiding light for our higher selves that we may strive always to build communities with equity and for diverse human environments to be respected with dignity maintained. This is no time to eliminate the Human Rights Commission of El Dorado County, but more aptly to reinvest in this important commission. To be better, it must first exist.

Hello Clerk of the Board,

Please send my email, which addresses 3/14/23 BOS meeting, Item 23-0283, to all Supervisors.

First, I want to thank my County for choosing to show their commitment to Human Rights by having a group with that as their designated mission area visible to all who visit our county website. That in itself makes a difference in furthering human rights in our communities. I also value knowing that some of our current supervisors have chosen to serve on this all volunteer board as a further sign of this county's commitment to human rights. Please do not lose that value to all of us. <u>What we do not name or do not measure</u> we do not usually do.

Hate crimes, like domestic violence, often are not reported by victims so official crime data will always be less than their occurrence. Ensuring that our Sheriff's Office has had recent training on investigating and determining whether an incident includes a hate crime, would further the County's commitment to Human Rights. Hate crimes are on the rise in CA and the nation so probably are here, too. School bullying data remain at about one-third having been a victim. With recent training, the Sheriff's Office could provide a speaker able to tell community members how they can help.

I also suspect that not all members of BOS have had the same expectations of our Human Rights Commission. For example, I can envision a Miwok speaker on their chosen topic might not overlap with any duties of the formal liaison between the county and their tribe. A consultation with the liaison about their scope, areas of potential conflict before topic with the speaker is firmed up could ensure that. Having helped plan bullying training when the law for schools was new, I found schools believed training and education is something they can do effectively for themselves. Dept. of Education does provide lots of resources that help.

I am glad there is such a liaison to, perhaps, facilitate better coordination between the tribe and local law enforcement on missing indigenous women, tribal victims of crimes, etc. in conjunction with the national effort. I also suspect we may have more Native American residents that are not members of our Miwok tribe than that are given that Cherokee is the tribe with more Californians than any other tribe.

Second, I believe that eliminating them is not the best solution and is at least premature. Providing staff support should be added or put in a budget and current BOS look at revisiting the ordinance and their function, mission.

Your best solution may be with more paths focused on human rights, entities partnering as appropriate, in addition to the hate crime enforcement by our Sheriff. Having the Human Rights Commission arranging for speakers, panels and/or forums—educational efforts. Then also funding non-profit agencies like Bridges, in their specialty areas, and/or Center for Nonviolent Conflict for their specialties, like bullying training, domestic violence for community engagement, responding to victims, holding reconciliation conversations between victims and perpetrators, etc. It is possible there are State or Federal grants to cover at least most of such costs.

I noticed that the Human Rights Commission in Humboldt County specifies areas where discrimination is forbidden by law as part of their function:

"Aid in eradication of discrimination in housing, employment, education, public accommodation, race, religious creed, color, national origin, ancestry, physical disability, mental disability, marital status, gender, sexual orientation, socioeconomic status, civic interest, or other factors." And cite more codes (California Government Code Sections 50262, 50264, and 50265; County Ordinance Nos. 2294, 2177, 1444, 1023, 663, 572, and 530). <u>https://humboldtgov.org/1308/Human-Rights-Commission</u>

Such a scope would permit targeted presentations to our realtors' association, for example, other community groups, and our agencies with housing, employment, public accommodations' responsibilities, in addition to community-wide venues.

Dear Supervisors,

Our Human Rights Commission was established in March, 2018 by Supervisors Novasel and Frentzen with the goal to promote tolerance and mutual respect between all persons, and to promote positive human relationships for the purpose of ensuring public peace, health, safety and the general welfare.

To me, Human Rights expand even further. In El Dorado County, Human Rights Issues include: Access to housing after the Caldor fire, freedom from domestic violence, access to water, access to food, shelter, medical care and safety for our elderly community members, access to clean air for all residents (particularly during fire season), access to food, shelter and medical treatment for unhoused people, access to healthy rivers, forests and land, and freedom from persecution for vulnerable groups of people (identified in CA State Government Code Title 5, Article 10, 50260-65).

Clearly, the work and infrastructure needed to support human rights is enormous. Creating a county Human Rights Commission is just one step in supporting human rights, but it is an important one. By establishing a Human Rights Commission, a county demonstrates that it prioritizes its people. I am proud that El Dorado County chose to create a Human Rights Commission.

Despite the 18 hour/ year time allocation granted by the Board for the commission, along with a global pandemic, the commission was active and made positive and impactful contributions to the community. At the January 24, 2023 BOS meeting when the issue of disbanding the commission arose, one Supervisor said, "I personally can't articulate what this commission has done to help the Board or the county." In this letter I would like to offer, to the best of my ability, information on what the Human Rights Commission has been doing for the Board and our county since it began.

March 7, 2017

(Item 26, File 17-0255) the Board adopted Resolution 048-2017 Promoting Civility, Respect, Tolerance, and Human Rights and formed an ad hoc committee consisting solely of Supervisors Novasel and Frentzen to work with staff on the potential establishment of a Civil/Human Rights commission. The purpose of the commission is to promote tolerance and mutual respect between all persons, and to promote positive human relationships for the purpose of ensuring public peace, health, safety and the general welfare.

March 20,2018

The Human Rights Commission was established by the El Dorado County Board of Supervisors (Ordinance 5081)

When the Human Rights Commission began, newly appointed commissioners were told they would be meeting 18 hours/ year

2018-2019

The Human Rights Commission established "Purpose", "Vision Statement," and "Bylaws." Commissioners underwent training including Brown Act Training. Commissioners engaged in networking and outreach. HRC arranged presentations to HRC from the Sheriff's HOT Team, New Morning Youth and Family Services, the Director of the Georgetown Divide Public Utilities District, the County Council and others.

In early 2019, Commissioners Simpkin, Gularte and Supervisor Novasel created an ad hoc committee to create a Public Human Rights Forum. They met regularly through July, 2019.

July 22, 2019: EDC Public Human Rights Forum

County stakeholders representing vulnerable populations were invited to share thoughts on the most pressing, local, human rights-related needs. Over a dozen organizations were represented.

Speakers included:

Juline Aguilar, NAMI (topic: mental Illness), Randy Peshon, Sheriff's Dept (Homeless Outreach Team), Peter Brown, The Lighted Candle (topic: unhoused people), Lisbeth Powell, Commission on Aging (topic: seniors /aging), Michael Saunders, Civil Rights Now, (topic: civil rights), Dale Wallerstein, Temple Kol Shalom (topic: religious freedom), Teri Monterosso, EDC Public Defender (topic: mentally ill in the criminal justice system), Ed Manansala, EDC Office of Education (topic: vulnerable student populations), Bill Martinez, Family Resource Center (topic: immigration/minorities), Bill Roby, El Dorado Community Foundation (topic: 2020 Census)

2020

HRC began developing a "Strategic Plan." Commissioners continued local outreach, networking and research. Commissioner Susan Simpkin presented data on county population groups, needs met, needs unmet, and challenges.

May (?) 2020

HRC was placed on hiatus during Covid

June 22, 2020

Master Report, File Number 20-0840: "Supervisor Parlin recommending to the Board consider providing direction to the Human Rights Commission to require that the Commission update its bylaws with language to create a formal process for issues brought before them before putting issues on their agenda."

Supervisor Parlin proposed two alternatives:

1. To put the Commission on hiatus and designate an ad hoc committee of two Supervisors to create a process for the Commission, or,

2. To disband the Commission and rely on established services and organizations to meet the Human Rights needs of the County.

September 28, 2020

HRC began meeting again. In response to Supervisor Parlin's request, the commission requested funding for training in Implicit Bias and Good Governance for the Human Rights Commissioners.

December 8, 2020

The Board denied funding to HRC for Training. (12-8-20 Ordinance 5134, Item 20-1447)

The Board of Supervisors redlined Commission responsibilities and changed bylaws. (12-8-20 Ordinance 5137-Redline). Ordinance no. 5134 was adopted. 2.20.1108 C. was changed by deleting this responsibility of the Commission : "C. To inquire into incidents of tension and conflict among or between people, including people subject to prejudice and discrimination due to race, religious creed, color, national origin, ancestry, physical disability, mental disability, marital status, gender, sexual orientation, socioeconomic status, civic interest, or any other factors, and to take action by means of conciliation, conference and persuasion to alleviate those tensions and conflict."

The BOS also redlined the terms of the commission by deleting Sec. 2.20.1112. - Initial term of Commission.

"The Board seeks to ensure the Commission functions to its designed purpose. From the effective date of ordinance 5081 (April 20, 2018), the Board hereby establishes a two-year evaluation term for the Commission. The Commission shall become inoperative two years from the effective the date of ordinance 5081 unless extended by the Board at a regular meeting and pursuant to Government Code § 25120 et seq."

2021

Commissioners attempted to address the needs of the Council and community while working with County Supervisors. Covid took a toll on the county but Commissioners continued to meet. HRC continued to engage in outreach and planning for educational presentations. Lara Gularte chaired a discussion on "Implicit Bias." Sue Novasel submitted a report on Implicit Bias on October 25, 2021.

November, 2021

HRC began developing a plan to present a forum on homelessness in the county.

January 3, 2022

HRC created an ad hoc committee composed of Commissioner Gularte and Supervisor Novasel, and chaired by Commissioner Carr, to design and implement a public forum on the homeless. Development of the forum continued through June.

Commissioners began implementation of education on designated monthly observances (such as Native American Heritage month, Black History Month, etc.) at each public, monthly meeting. Commissioners traded responsibilities.

April 25, 2022

HRC Meeting featured Guest Speakers Ed Manansala (El Dorado County Superintendent of schools), Chris Moore (El Dorado County Assistant Superintendent of Schools), and Aaron Palm (Principal of Oakridge High School). Discussion emphasized how schools are addressing instances of bullying and discrimination both at sites and at the district level.

May 23, 2022

HRC Meeting featured Guest Speaker and Civil Rights Attorney, Mark Merin. Mr. Merin presented a talk on the difference between Civil Rights and Human Rights.

June 13, 2022: Forum: "A Day in the Life of a Homeless Person"

This forum centered on addressing the needs of the unhoused residents of the County. About a dozen stakeholders were invited to speak and to provide resources to the community.

Speakers included:

Captain Salkenstein (EDC Sheriff Homeless Outreach Team), Cheyenne Purrington (Tahoe Coalition for the Homeless), Margaret Lewis (El Dorado Opportunity Knocks, Continuum of Care), Maureen Dion-Perry (Housing El Dorado), Ron Marlette (Upper Room Dining Hall), and several members of the unhoused community.

60 county residents attended the forum and over 100 Survey Monkey responses were collected. Commissioner Carr developed strong relationships with stakeholders and is still in contact with a number of them.

August 22, 2022

Commissioners Simpkin and Gularte recommended a Speaker Series. Elena De Lacy, Executive Director of the American River Conservancy, was posited as a possible speaker to discuss "How Human Rights and the Rights of Nature Intersect." Supervisor Hidahl discussed working with the interfaith community.

September, 2022

Commissioners continued developing the Speaker Series. Supervisor Hidahl discussed the possibility of including representatives of local tribes and school representatives.

September (?), 2022

Commissioners Carr and Valicenti attended CA Attorney General Rob Bonta's webinar work group on Hatred Against the AAPI Community. This working group included recommendations regarding how to deal with anti-AAPI hate and a list of resources that are now available to the public.

October 24, 2022/ November 8, 2022

Report on the "A Day in the Life of a Homeless Person" was presented to the BOS.

November 28, 2022

Commissioners Carr and Valicenti reported on California Resources to Address Hate Crimes webinar.

Commissioners Simpkin, Gularte and Valicenti recommended a proposal for the 2023 speaker series plan.

In 2018 I was delighted to learn that the Board of Supervisors had adopted an ordinance establishing a Human Rights Council. Having lived here over 40 years, I have been aware of (and even experienced) occasional acts of bullying myself. (My "sin" is that I am old.) Individuals and groups also harass people targeted for a variety of reasons. (race, appearance, address, ability to defend themselves.) These actions usually fall below the level of chargeable crimes, but they create an atmosphere of intimidation and unease. Some even rise to the level of physical damage to the victims...or the victims are afraid to place charges for fear of retribution. This is happening in schools, homes, even on the public streets.

I thought a commission on human rights is just what we need to address uncharged or unchargeable acts of cruelty.

I was sorely disappointed when, in 2020 the Board, led by one supervisor, decided to delete actually addressing acts of harassment, racial malice, or simple intimidation, from the HRC's bylaws.

I thought, "Ugh! The Board wants to water it down so they can pretend that everything's fine."

Please allow the Human Rights Commission to continue. They have done good work, especially facilitating getting services to the homeless. They can do even more if you support them rather than lob obstacles in their way... or try to pass them off to some non-profit whose priorities are elsewhere.

Dear Supervisor Thomas,

I attempted to send an email earlier today, but I am not sure if it transmitted; so, I am making a second effort. By the way, I sent you an email in early February (slightly more than a month ago), but have yet to receive a reply. I am a constituent (Camino), and I voted for you. To say that I am disappointed in your posture vis-à-vis the HRC is an understatement. I have generally viewed you as a moderately conservative leader, one not driven by ideology but rather by principle. Frankly, I fear that your position on this issue belies that image.

Before I get to the specifics of my argument I ask you to consider the words of my former boss, President Jimmy Carter, who has pointed out that "America did not invent human rights. In a very real sense, it is the other way around." That is a powerful sentiment, and it is extremely relevant to the current debate.

My key points are as follows:

- Human rights are under assault around the globe. El Dorado County should be a bulwark against such assaults, not an enabler;
- There have been a number of human rights abuses in El Dorado County over the past few years; citizens should have an <u>official</u> channel through which to voice concerns about such abuses;
- Protection of human rights is a legitimate and necessary function of government; shifting that responsibility to a non-profit entity is a fig leaf that doesn't provide the cover or protection you think it will;
- We should want to make El Dorado County a welcoming community to all people, not a hostile one;

• This is a time for political courage, not bowing to extremists' agendas.

I truly hope you and your colleagues will consider my view with the same seriousness with which it is offered.
