Dear Senator Mitchell:

The County of El Dorado urges your support for the County Welfare Directors Association (CWDA) request to provide \$5 million to support statewide training of social work staff in the Adult Protective Services (APS) program. These trainings are critical in ensuring our APS workers are prepared to effectively protect and serve elder and dependent adult victims of abuse and neglect.

California's population of elderly is growing at an exponential rate and the result is an increasing demand for local services such as APS. County welfare agencies provide 24/7 response to reports of abuse and neglect of elders and dependent adults.

APS workers are the first-line of defense against elder and dependent adult abuse and must be prepared to respond to crisis. In extreme cases, APS services are lifesaving. Our workers must be well versed in the laws and have the necessary skill sets to conduct investigations, often jointly with local law enforcement, on a myriad of cases including financial abuse. APS social workers help vulnerable elders, dependent adults, and their families navigate complex systems and obtain needed services. A well-trained workforce is necessary to help victims remain safe in their own homes, thus avoiding hospitalization and institutional care, such placement into nursing homes, which are much more costly to tax payers.

The State is responsible for funding and delivering APS training to ensure statewide consistency and quality of APS services. However, with less than \$100,000 available for APS training statewide, there is simply not enough training for our APS staff. The result is an undertrained workforce that is challenged to meet the growing demand for services. A strong training infrastructure is critical to ensuring statewide quality in direct services to victims of elder and dependent adult abuse and neglect.

We believe the requested \$5 million will serve as a critical investment in the quality and effectiveness of APS services and will enable us to meet the increasing needs of our aging population. For these reasons, the County of El Dorado urges your support.
