

**B. PURPOSE:** The purpose of this modification is to extend the completion date.

**C. DESCRIPTION:** This modification is hereby:

1. Extends the completion date to December 31, 2010 due to complementary funding from the State of California was no available during the 2009 State funding freeze.
2. Revises A.7 PERFORMANCE PERIOD to December 31, 2010.
3. Replaces page 1 and 3 of basic Agreement with page 1 and 3 Modification 0004.

**D. ADJUSTMENT OF AGREEMENT AMOUNT:** The total estimated amount of the agreement remains unchanged at \$375,000.00.

**E. NOTICE OF CHANGE IN FUNDS OBLIGATED:** The total amount of funding obligated remains unchanged at \$405,000.00.

**F. ADJUSTMENT IN AGREEMENT TIME:** As a result of this modification, the period of performance is hereby changed from date of execution through December 31, 2007 to September 29, 2005 through December 31, 2010.

1. Obtain all applicable Federal, State, and local permits for work to be performed under this agreement.
2. Remove the existing impassable culvert.
3. Install a new bridge (bottomless culvert) or baffled structure that is passable by fish.
4. Remove unnecessary fill from below the Lake Tahoe Boulevard crossing to expand the floodplain.
5. Restore 0.25 mile of the Angora Creek channel upstream of the Lake Tahoe Boulevard crossing.
6. Install and maintain temporary water pollution control measures through all phases of construction.
7. Provide Reclamation with a written project progress report at the end of the first construction season.  
Due Date: December 31, 2010
8. Provide Reclamation with a written project progress report at the end of the second construction season should the project need to be phased.  
Due Date: December 31, 2007
9. Provide Reclamation with a written final report. Include funding information, project goals, scope of work, a description of the completed project, and pre- and post-project photographs.  
Due Date: December 31, 2010

- Why is this on a different form? Modification #003 was done with a 'Modification of Assistance Agreement' document. If we are using the correct form I will just need a reason why.
- Page 3 of the Agreement has old due dates in A.5. #7, 8, and 9. #7 should read December 31, 2010. #8 does not apply to this project, it will be completed in 1 construction season. #9 should

also read December 31, 2010.

- Also on Page 3, A.8 Funding does not reflect the actual grant amount of \$405,000 (see modification #002).
- Does the County need to sign the Acceptance section (16a)? If not, is there something official from the BOR that states that this modification can be made unilaterally? I will be challenged on this.
