AGREEMENT FOR SERVICES #010-S0811 AMENDMENT I

THIS AGREEMENT made and entered by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Xerox Corporation, a New York corporation, duly qualified to conduct business in the State of California, whose principal place of business is P.O. Box 1600, Stamford, CT 06904 and whose local place of business is 2485 Natomas Park Drive, Suite 250, Sacramento, CA 95833 (hereinafter referred to as "Contractor");

WITNESSETH

WHEREAS, Contractor has been engaged by County to provide professional services to install new Xerox 4110 Enterprise Printing System; basic operating training; System Administrator training; system and application implementation; and equipment maintenance and supporting software license and support for the Information Technologies Department, in accordance with Agreement for Services #010-S0811, dated June 26, 2007, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to modify the term of said agreement without changing compensation, hereby amending **ARTICLE II – Term**.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #010-S0811 shall be amended a first time as follows:

ARTICLE II

Term: This Agreement shall become effective upon final execution by both parties hereto. The term of this Agreement shall be for the period of July 27, 2007 through July 26, 2010. This agreement may be extended for one additional three (3) year period, if mutually agreed to by both parties hereto, in writing not less than thirty (30) days prior to the expiration of this Agreement.

Except as herein amended, all other parts and sections of that Agreement #010-S0811 shall remain unchanged and in full force and effect.


