AGREEMENT FOR SERVICES #316-S1611 / #598

AMENDMENT IV

This Amendment IV to that Agreement for Services #316-S1611, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Mother Lode Van & Storage, Inc., a California Corporation duly qualified to conduct business in the State of California, whose principal place of business is 11255 Pyrites Way, Suite 400, Rancho Cordova, California 95670 (hereinafter referred to as "Contractor").

RECITALS

WHEREAS, Contractor has been engaged by County to provide moving services and modular furniture disassembly, inventory, removal, and reinstallation services on an "as requested" basis for the County facilities both on the East Slope and West Slope of El Dorado County, in accordance with Agreement for Services #316-S1611 dated January 26, 2016, Amendment I dated May 27, 2016, Amendment II dated June 6, 2016, and Amendment III dated July 20, 2017, all incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend term of said Agreement, hereby amending **ARTICLE II – Term**; and

WHEREAS, the parties hereto have mutually agreed to increase the total amount of said agreement by \$100,000.00 for a new not-to-exceed amount of \$600,000.00 and revise Exhibit "A" marked "Revised Fee Schedule" effective February 1, 2019, hereby amending **ARTICLE III – Compensation for Services**.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #316-S1611 shall be amended a fourth time as follows:

ARTICLE II is hereby replaced in its entirety to read as follows:

Term: This Agreement shall become effective upon final execution by both parties hereto and, as amended, shall cover the period of February 1, 2016 through January 31, 2020.

ARTICLE III

Compensation for Services paragraphs 2 is amended to add the following:

Effective February 1, 2019, the billing rate shall be billed in accordance with Exhibit "A" marked "Revised Fee Schedule Effective February 1, 2019", incorporated herein and made by reference a part hereof.

Compensation for Services paragraph 4 is hereby replaced in its entirety with the following:

The total amount of this Agreement, as amended, shall not exceed \$600,000.00, inclusive of all Work Orders, costs and expenses.

Except as herein amended, all other parts and sections of that Agreement #316-S1611 shall remain unchanged and in full force and effect.
