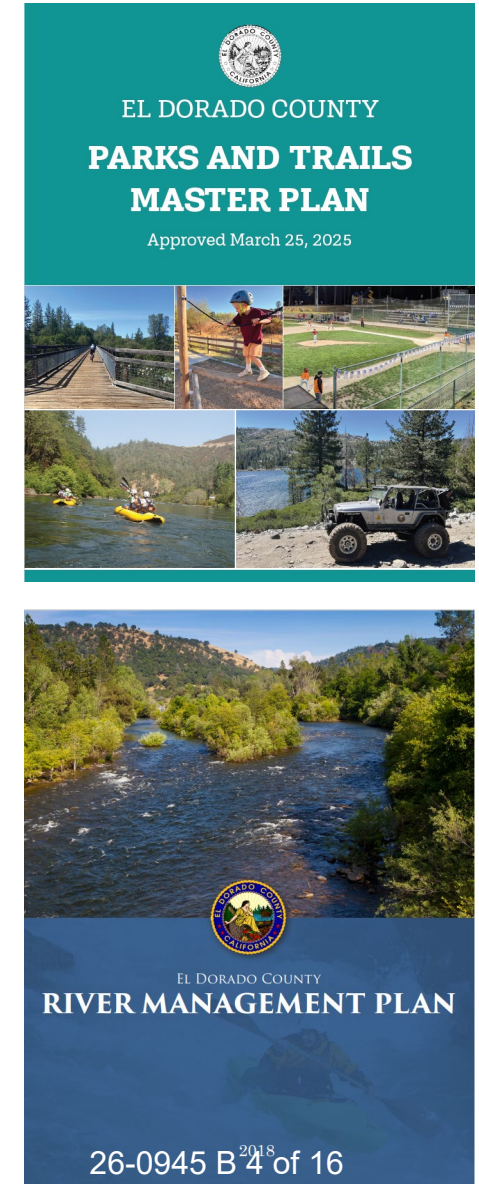

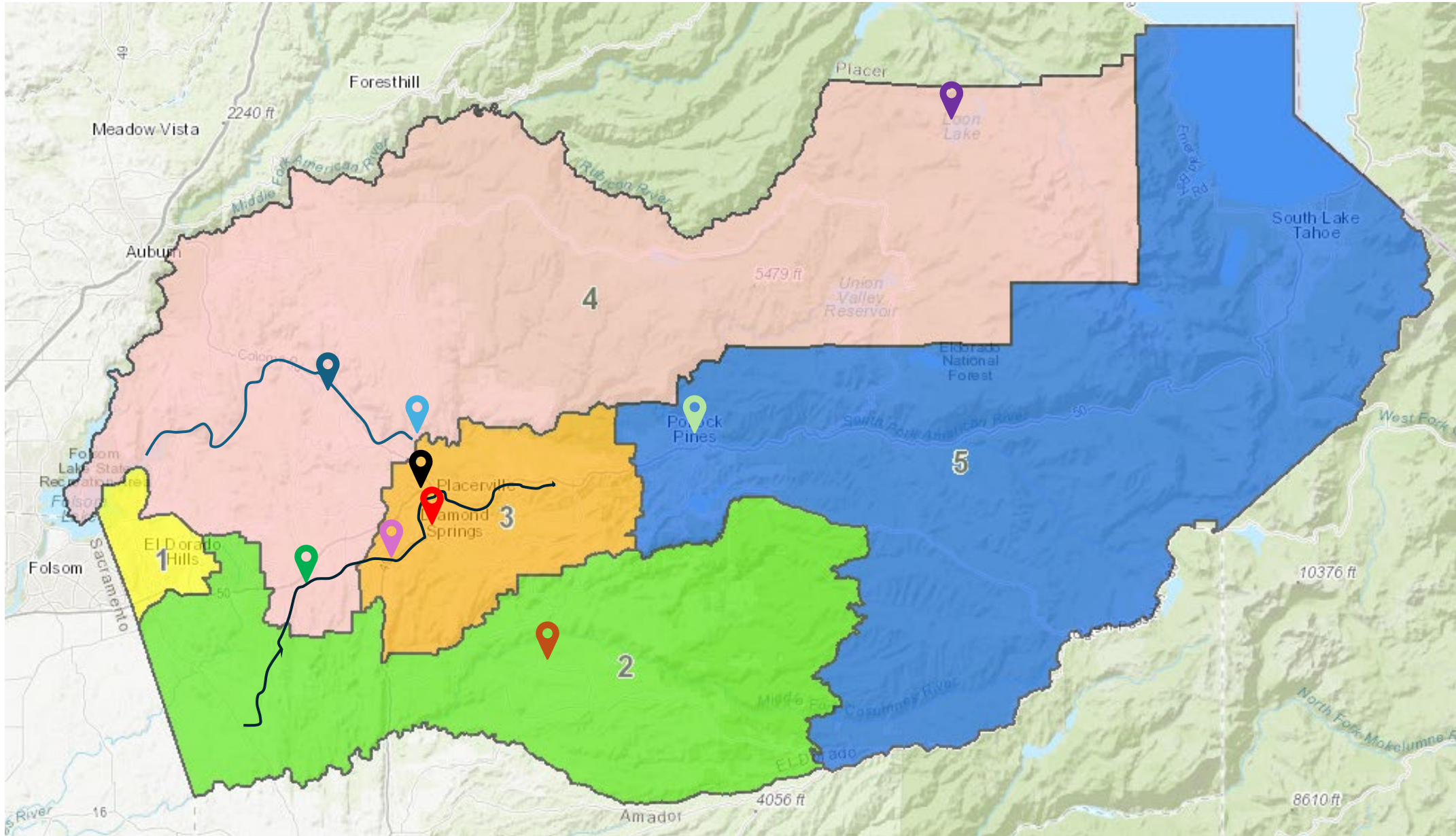

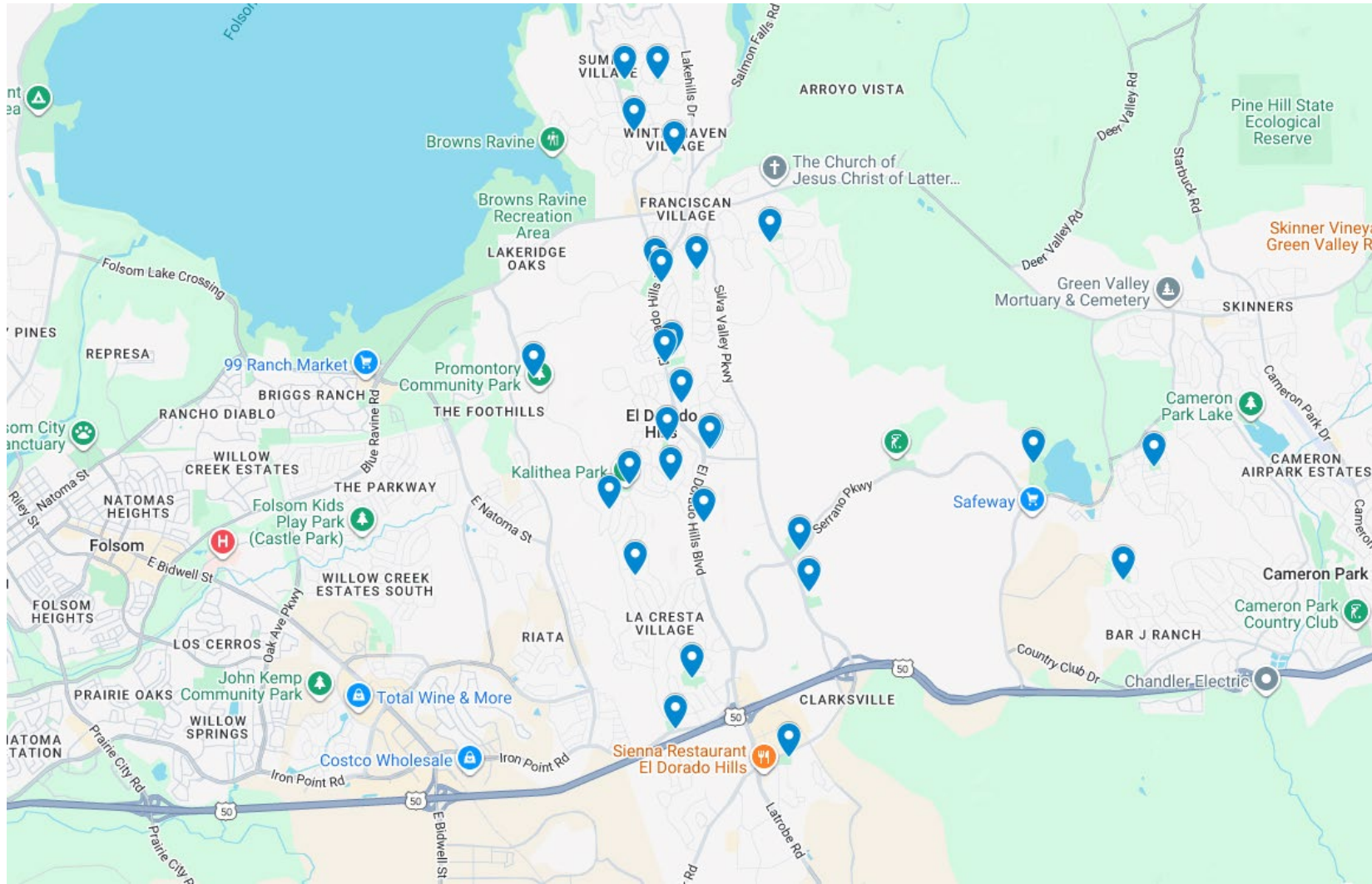

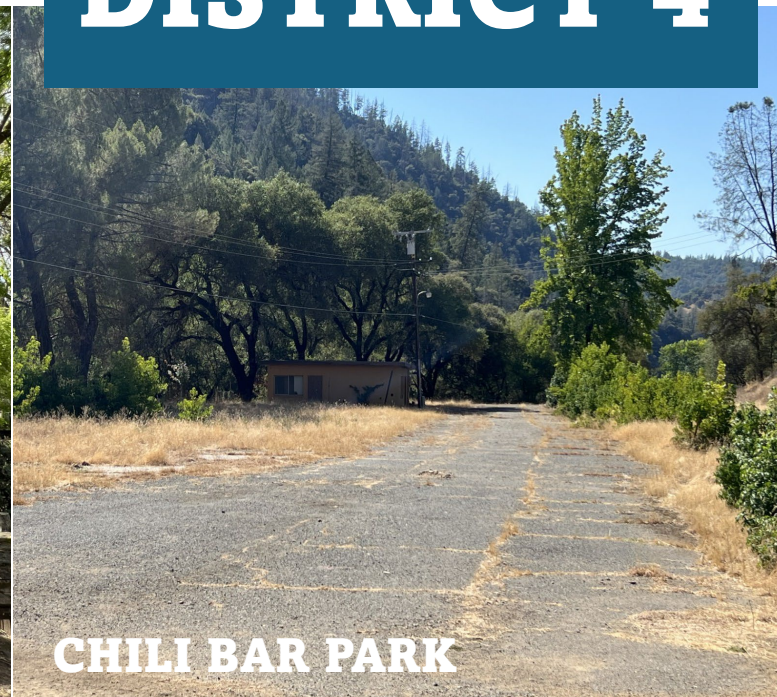

PARKS & RECREATION COMMISSION FY 2025-26 CHALLENGES

Building on the volunteer base for parks and trails – assist staff and volunteer groups in promoting community involvement in the maintenance and promotion of our parks and trails.

Staffing constraints due to budget reductions – the FY2025/26 budget will directly impact staffing in the Parks and Recreation Department. The Commission will endeavor to assist staff in whatever areas most beneficial to the department.

Vacancies within the Parks and Recreation Commission – it is hopeful that the Commission will be fully appointed in the very near future.

Funding for construction, maintenance and enhancements – funding is an ongoing issue, and the Commission will review and support staff in any applications for funding.

FY 2025-26 GOALS

- Continue to provide a **public forum** for discussion of parks and recreation concerns and opportunities ([Master Plan Initiative 4.2.1](#))
- Review and update **County Ordinance Sec. 2.20.660-750** to repeal and replace with a resolution and supporting bylaws
- Aid in the development of a **Cost Recovery Program** for County-owned and operated recreation facilities ([Master Plan Initiative 3.2.6](#))

District 2

- Aid efforts to develop a park in the community of **Grizzly Flats**
- Aid efforts to develop a **30-acre trailhead** in El Dorado Hills

District 3

- Support staff in recruiting a volunteer base and providing motivational support for retention of volunteer to assist with volunteer activities at **Old Depot Bike Park** and the natural trail section of **El Dorado Trail** ([Master Plan Initiative 4.1.4](#))

District 4

- Update the **River Management Plan** and County Ordinance 5.48 Streams & Rivers Commercial Boating ([Master Plan Initiative 1.4.10](#))
- Review **Henningsen Lotus Park** master plan and provide recommendations to the Board of Supervisors for options to increase cost recovery and proposed frequency of closing the park for private special events and filming ([Master Plan Initiative 3.1.11](#))

District 5

- Continue to support the **Forebay Park** improvement project and assist with fundraising for future phases ([Master Plan Initiative 3.1.1](#))

- Represent the Parks Division through attending tablings, events, and public meetings to interact and engage with the public
