**RESOLUTION NO. 176-2010**

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO  
AUTHORIZING A CHANGE IN CRITERIA FOR PROGRAM IMPLEMENTATION UNDER FY 2008-09  
COMMUNITY DEVELOPMENT BLOCK GRANT ENTERPRISE COMPONENT GRANT #08-EDEF-5877 TO  
INCREASE THE MICROENTERPRISE LOAN PURPOSES FROM FACADE IMPROVEMENT LOANS TO  
INCLUDE START-UP AND EXPANSION LOANS, AND AUTHORIZING SUBMITTAL OF THE CHANGE  
TO THE CALIFORNIA STATE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT.

**WHEREAS**, the Department of Human Services, on behalf of the County of El Dorado, applied for and was awarded a \$300,000 FY 2008-2009 Community Development Block Grant Enterprise Fund Standard Agreement #08-EDEF-5877 for the Microenterprise Business Facade Improvement Loan Program, and

**WHEREAS**, increasing the eligible loan purposes of the microenterprise assistance activity funded under Agreement #08-EDEF-5877 to include start-up and expansion loans, shall continue to meet the CDBG National Objective requirement of benefiting low- and moderate-income persons by providing microenterprise loans to low-income microentrepreneurs, and

**WHEREAS**, the El Dorado County Economic Development Strategy dated October 2, 2007 cites the measure of establishing a facade loan program and small business revolving loan fund to provide for the goals of business retention and expansion, and entrepreneurship attraction, and

**WHEREAS**, a public hearing has been conducted to allow public to comment and provide input on the changes to program implementation of the grant award.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of El Dorado hereby authorizes a change in criteria for program implementation under FY 2008-09 Community Development Block Grant Enterprise Component Standard Agreement #08-EDEF-5877 to increase the microenterprise loan purposes from Facade Improvement Loans to include start-up and expansion loans, and authorizes submittal of the change to the California State Department of Housing and Community Development.
