First let me say that this item NEVER seems to be timely prepared for the Boards consideration. After eight continuations, most recently 11-10-09 & 12-10-09; the item arrived very late Friday 01-15-10 with papers that did not indicate who prepared or submitted them and without a date or time stamp! There was also an addendum, but earlier in the day, revising the action to be taken. And, why doesn't the BOS receive a document indicating the changes made, why must we always compare the total document??

As you all know, I have spent a great amount of time on this issue which is partially illustrated by my email dated November 30, 2009 (copy attached). Via that e-mail I advised all parties of my desired or proposed changes. The documents appear not to have considered my efforts.

As to the "Amendment to Lease":

In line 2 of the second whereas, after the word "improvements", there should be the word <u>on;</u> The exhibits are not properly identified.

As to the Memorandum:

The comments made in my e-mail are neither made in the documents nor discussed in a cover letter. Other than the addition of the last sentence at the end of section III.A, I found no changes from the document submitted 11-25-09.

As to Process:

We have been provided a copy of the signature page from the City of SLT attached to the MOU. What about the lease modification which I believe MUST come before the MOU? The MOU without the lease amendment puts us back to my comments of 6-25-09 and ignores my memo of 10-19-09 and others. When will I get answers rather than the "bums rush" to approval?
