

## Proof of Publication of ORDINANCE

#### **PUBLIC NOTICE**

The Board of Supervisors will consider adoption of Ordinance 5096 at their regular meeting of December 4, 2018.

ORDIŃANCE 5096 WILL REPEAL ORDINANCE 4385 AND REPEAL AND REPLACE EL DORADO COUNTY ORDINANCE NO. 4325 – PROVIDING FOR PUBLIC WATER PLANNING, TO READ AS FOLLOWS:

Section 1. New Parcels.

Purchase of a water meter is mandatory prior to approval of all new residential final parcel or subdivision maps or development projects which require public water service.

Section 2. State Statutes.

Projects shall comply with all applicable state statutes.

Section 3. Posting of Water Management Plans

Preparation and posting of the Countywide Water Management Plan and updates and Urban Water Management plans shall be as provided for in a Memorandum of Understanding between the County of El Dorado and the El Dorado County Water Agency.

Section 4. Severability.

If any section, subsection, sentence, clause, phrase, part or portion of this ordinance is for any reason held to be invalid or unconstitutional by a final judgement of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. It is hereby declared that this measure, and each section, subsection, sentence, clause, phrase, part or portion thereof would have been adopted or passed irrespective of the fact that one or more sections, subsections, sentences, clauses, phrases, parts or portions be declared invalid or unconstitutional.

Section 5. <u>Tahoe Regional Planning</u> Agency Exclusion.

This ordinance shall not apply to any projects or parcels within the jurisdiction of the Tahoe Regional Planning Agency.

Section 6. By adoption hereby the Board of Supervisors has authorized the filing of a Notice of Exemption for purposes of the California Environmental Quality Act.

This ordinance shall take effect and shall become effective thirty (30) days following the adoption hereof.
