### 7. Committee Member Comments:

Tim Lasko wanted to add to the past discussions about inner tubers that they have a right to there and that to be inclusive with discussions.

Mariyln Tahl said she and Keith Gershon took the Sherriff D'Agostini down the river from Marshall Gold State Park to Camp Lotus to point out possible problems and a dialogue for future communication. He was invited to attend an RMAC meeting in the future.

Keith Gershon added that it was a positive day and that the Sherriff saw that the river is an important resource to the County.

Stephen Liles said that illegal commercial rafting ("pirate boating") is a real problem. There are former commercial rafts being used for pirate trips and his insurance company has told him that they have insurance policys for none outfitters for the S. Fork. There is no enforcement of the law or ordnances by State Parks and El Dorado County Sheriffs office that can enforce laws and should do investigations. He would like them to do more.
