

**MEMORANDUM OF UNDERSTANDING #MOU-19-6037 (County #4178)**  
**AMENDMENT I**

---

**This Amendment I** to that Memorandum of Understanding #MOU-19-6037 (County #4178) is made and entered into by and between the California Department of Social Services (hereinafter referred to as "CDSS") and the County of El Dorado, a political subdivision of the State of California; (hereinafter referred to as "County");

**RECITALS**

**WHEREAS**, County has contracted with CDSS to implement Medi-Cal Privacy and Security according to Memorandum of Understanding (MOU) #MOU-19-6037 (County #4178) dated September 27, 2019, incorporated herein and made by reference a part hereof;

**WHEREAS**, the parties hereto have mutually agreed to amend Article **XVIII. Termination** of said MOU, hereby extending the termination date of the MOU; and

**WHEREAS**, unless otherwise specified herein, the following terms and conditions shall be effective upon final execution of this Amendment I to that #MOU-19-6037 (County #4178).

**NOW THEREFORE**, the parties do hereby agree that #MOU-19-6037 (County #4178) shall be amended a first time as follows:

Article **XVIII. Termination** shall be amended in its entirety to read as follows:

**XVIII. Termination**

- A. This Agreement shall terminate on March 1, 2023, regardless of the date the Agreement is executed by the parties.
- B. **Survival:** All provisions of this Agreement that provide restrictions on disclosures of Medi-Cal PII and that provide administrative, technical, and physical safeguards for the Medi-Cal PII in the County Department/Agency's possession shall continue in effect beyond the termination or expiration of this Agreement, and shall continue until the Medi-Cal PII is destroyed or returned to CDSS.

Except as herein amended, all other parts and sections of that #MOU-19-6037 (County #4178) shall remain unchanged and in full force and effect.
