FIRST AMENDMENT TO AGREEMENT FOR SERVICES #485 (#252-S1611)

THIS FIRST AMENDMENT to that Agreement for Services #485 (#252-S1611) made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and WebQA, Inc., a corporation duly qualified to conduct business in the State of California, whose principal place of business is 900 S. Frontage Road, Suite 110, Woodridge, IL 60517, now operating as GovQA, LLC, a limited liability company duly qualified to conduct business in the State of California, whose principal place of business is 408 Saint Peter St, Suite 600 Saint Paul, MN 55102 (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, WebQA, Inc. has been engaged by County to provide a non-exclusive, non-transferable, limited license to access GovQA Freedom of Information Act (FOIA) applications pursuant to Agreement for Services #485 (#252-S1611), dated January 26, 2016, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, WebQA, Inc. converted and changed its corporate name to GovQA, LLC, a Delaware limited liability corporation, effective June 26, 2019;

WHEREAS, the parties hereto agree to amend the Agreement to reflect the corporate name change and update the notice recipients, amending **Article XVI, Notice to Parties**.

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

- I. All references in the Agreement to WebQA, Inc. shall be changed to GovQA, LLC.
- II. **ARTICLE XVI, Notice to Parties** is amended in its entirety to read as follows:
