Commissioner McIver: No announcements.

Commissioner Lowery: Asked if anything has evolved at Rasmussen Park. Rotary Club in El Dorado Hills will host a crab feed on January 28, 2023 and to save the date. More details to come. Thanked new Parks Staff for a job well-done at Parks Commission Meeting.

Commissioner Cumpston: Spoke about the Grizzly Flats tour and how inspiring it was. Rode his bike on the El Dorado Trail and used Highway 50 under crossing. Mentioned how it will be a huge draw for cyclists with the ability to ride over to Apple Hill. He didn't see any signs directing cyclists from the trail and asked if there were plans for that. Asked for completion status on reconstructing the access to the El Dorado Trail at WalMart since it is affecting public access.

Commissioner Bryson-Johnson: Talked about Grizzly Flats tour on October 28, 2022 with Commissioner Cumpston, Parks Manager Vickie Sanders, and resident Robin Kelly. Discussed potential site for building a community center.

STAFF COMMENTS AND ANNOUNCEMENTS

Parks Manager, Vickie Sanders: Responded to Commissioner Cumpston inquiry about signs on the El Dorado Trail. She will speak with Department of Transportation about the signs. Also responded on the inquiry from Commissioner Cumpston about the status on the El Dorado Trail access at WalMart. That is a Department of Transportation project. She knows there were delays but does not have an anticipated date of completion for the redesign of the access. Completed interviews for the Parks Program Coordinator and has selected a candidate. She and Jennifer Franich interviewed for the Analyst position. No candidate selected, and they are waiting for a new list of candidates to interview. Mention of new staff. Nick, Parks Trail Maintenance Worker and Jessica, Administrative Technician.

Principal Management Analyst, Jennifer Franich: Next Stakeholder Meeting is December 14, 2022 at 5:30pm. Service clubs will be invited such as rotary clubs and school districts for different perspectives. Open invitation for two commissioners to attend. Commissioner Lowery and Cumpston attended the last meeting. Planning first community workshop near the end of January 2023 and will notify people in December to save the date. Has an item for the Board on December 6 and hopeful the Board will appoint an AD-HOC committee to talk about Chili Bar.
