It seems to me that the Peirroz Rd building could indeed be a good LONG TERM navigation center, and provide potential sheltering later as well, perhaps to a slightly different clientele than Perks Ct—but that is unknown.

The County needs to move ahead on a response to homeless needs NOW, even though Perks Ct is not long term. It is a necessary start on Perks Court. Timing is of the issue, and delayed timing has a fiscal cost too.

Let's move ahead on the shorter term, get it going, and then turn attention to the longer term. We cannot do everything at once.
