

**AGREEMENT FOR SERVICES #289-S0611
AMENDMENT III**

The Third Amendment to the Agreement for Services #289-S0611, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and York Risk Services Group, Inc. (as assignee of York Insurance Services Group, Inc.- California (formerly known as Gregory B. Bragg & Associates, Inc.), duly qualified to conduct business in the State of California, with a place of business at 1101 Creekside Ridge Drive, Suite 100, Roseville, CA, 95678 ("Administrator") is hereby amended on July 1, 2011 as follows:

RECITALS

WHEREAS, York Insurance Services Group, Inc. - California has been engaged by County to provide investigative, administrative and claims adjustment services relating to workers compensation claims against the County in accordance with Agreement for Services #289-S0611, dated September 1, 2005, incorporated herein and made by reference a part hereof; and

WHEREAS, Administrator represents that it is the parent company of York Insurance Services Group, Inc. – California. Administrator further represents that it unconditionally assumes all obligations of its subsidiary company under the Agreement and that York Insurance Services Group, Inc. – California agrees to remain liable for all of its obligations under the Agreement; and

WHEREAS, the parties wish to amend the terms of the Agreement; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #289-S0611 shall be amended to include provisions as follows:

ARTICLE II

Term: The term of this Agreement, as amended shall be for the period of November 1, 2005 through October 31, 2013.

ARTICLE III-

Payment and Invoices: For services provided herein, County agrees to pay administrator, in advance, according to the following schedule:

November 1, 2011 through October 31, 2013	\$21,750.00 per month
---	-----------------------

In addition, Administrator will provide optional risk control and special services listed in Appendix B amending the rate for Claims investigations (AOE/COE, fraud) to \$79.00 per hour and all other special services at the rate of \$125.00 per hour. The total amount of optional services requested shall not exceed \$30,000. Appendix B supersedes Appendix D entitled Optional Risk Control and Special Services. Appendix D is a duplication of Appendix B and is hereby deleted from Agreement.

Total amount of this Agreement, as amended, shall not exceed \$2,074,200.00 for the eight (8) year period.

ARTICLE XII (I)

Insurance: Section I shall be revised to reflect that York may maintain Third Party Crime Insurance in lieu of a fidelity bond.

Appendix D shall be revised to reflect that the hourly rate for Claims Investigations (AOE/COE, fraud) shall be \$79.00 per hour.

Except as herein amended, all other parts and sections of that Agreement #289-S0611 shall remain unchanged and in full force and effect.
