**IRREVOCABLE OFFER OF DEDICATION FOR
ROAD RIGHT OF WAY, LANDSCAPE AND PUBLIC SERVICE EASEMENT**

BUCKEYE UNION ELEMENTARY SCHOOL DISTRICT, A POLITICAL SUBDIVISION OF THE STATE OF CALIFORNIA, hereinafter called GRANTOR, owner of the real property herein described, does hereby irrevocably offer for dedication to the COUNTY OF EL DORADO, a political subdivision of the State of California, a Road Right of Way, including the underlying fee, and a Landscape and Public Service Easement for any and all public purposes, to erect, install, construct, remove, repair, replace, reconstruct, maintain and use, for public service purposes, any and all materials, fixtures, appliances, equipment, pipes, pipelines, wires and cables (including fiber optics) necessary for the transmission, distribution and delivery of electricity, water, sewer, storm water, gas, cable television, communication and information service utilities, together with any and all appurtenances thereto, including the right from time to time to trim and to cut down and clear away or otherwise control any trees or brush, to restrict trees placed within the limits of the Public Service Easement to a maximum height of fifteen feet (15') at maturity and prohibiting the construction of buildings, structures and wells within these areas, on, over, under and across that certain real property situate in the unincorporated area of the County of El Dorado, State of California, described as follows:

It is understood that this offer of dedication shall remain in effect and run with the land until such time the County of El Dorado Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution.

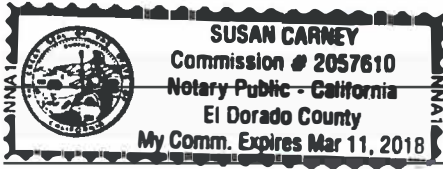

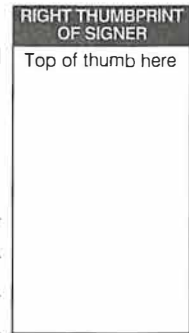
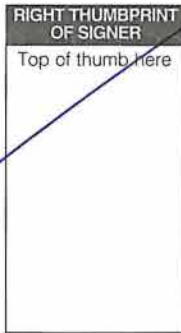

LEGAL DESCRIPTION**

All that real property situated in the County of El Dorado, State of California, being a portion of real property conveyed by deed to BUCKEYE UNION ELEMENTARY SCHOOL DISTRICT, A POLITICAL SUBDIVISION OF THE STATE OF CALIFORNIA, hereinafter referred to as "SCHOOL" Property, recorded in Document No. 2002-0095012-00 in the Official Records of said County, lying within the Southwest One Quarter of Section 6, T. 9 N., R. 9 E., M.D.M. and being more particularly described as follows:

Road Right of Way

Commencing at a 1-1/2" capped iron pipe stamped "LS 3864" marking the Northwest corner of Parcel "B" as shown on that certain Parcel Map, filed in the office of the County Recorder in Book 25 of Parcel Maps, Page 49; thence South 01°03'28" East 3093.91 feet to the **Point of Beginning**, being the Northeast corner of said "SCHOOL" Property; thence along the Easterly line of said "SCHOOL" Property South 01°02'27" East 451.26 feet to the Southeast corner of said "SCHOOL" Property; thence along the Southerly line of said "SCHOOL" Property South 89°54'50" West 32.26 feet; thence leaving said Southerly line North 01°01'20" West 393.41 feet; thence along the arc of a curve to the left, having a radius of 468.00 feet and being subtended by a chord bearing North 04°34'31" West 58.01 feet to a point on the Northerly line of said "SCHOOL" Property hereinafter referred to as **Point "A"**; thence along said Northerly line North 89°54'24" East 35.70 feet to the **Point of Beginning**, containing an area of 14,590 square feet, more or less.

Landscape and Public Service Easement

Beginning at the aforementioned **Point "A"**; thence leaving the North line of said "SCHOOL" Property along the arc of a curve, concave to the Southwest, having a radius of 468.00 feet, the chord of which bears South 04°34'31" East, 58.01 feet; thence South 01°01'20" East, 393.41 feet to a point on the South line of said "SCHOOL" Property; thence along said South line, South 89°54'50" West, 2.50 feet; thence leaving said South line, North 01°01'20" West, 393.41 feet; thence along the arc of a curve to the left, having a radius of 465.50 feet and being subtended by a chord bearing North 04°35'50" West, 58.05 feet, to a point on the North line of said "SCHOOL" Property, hereinafter referred to as **Point "B"**; thence along said North line, North 89°54'24" East, 2.52 feet, to the Point of Beginning, containing an area of 1,129 square feet, more or less.

Public Service Easement

Beginning at the aforementioned **Point "B"**; thence leaving the North line of said "SCHOOL" Property along the arc of a curve, concave to the Southwest, having a radius of 465.50 feet, the chord of which bears South 04°35'50" East, 58.05 feet; thence South 01°01'20" East, 393.41 feet to a point on the South line of said "SCHOOL" Property; thence along said South line, South 89°54'50" West, 18.93 feet; thence leaving said South line, North 00°45'59" West, 52.46 feet; thence along the arc of a non-tangent curve concave to the Northwest, having a radius of 1,375.00 feet, the chord of which bears North 02°08'07" East, 199.74 feet; thence North 02°01'48" West, 164.79 feet; thence North 05°42'06" West, 34.62 feet, to a point on the North line of said "SCHOOL" Property; thence along said North line, North 89°54'24" East, 9.80 feet, to the Point of Beginning, containing an area of 4,986 square feet, more or less.


