SECOND AMENDMENT TO AGREEMENT FOR SERVICES #8070

THIS SECOND AMENDMENT to that Agreement for Services #8070, made and entered by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Fostering Connections, A Professional Licensed Clinical Social Worker Corporation, a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 941 Spring Street, Suite #5 and/or #7, Placerville CA 95667, and whose Agent for Service of Process is Stephen J. Yun, 2612 Cleat Lane, Sacramento CA 95818, (hereinafter referred to as "Consultant");

RECITALS

WHEREAS, Consultant has been engaged by County to provide the Probation Department with sex offender counseling to certain clients of the Probation Department, in accordance with Agreement for Services #8070, dated October 18, 2023; and its Amendment I, dated August 19, 2025; incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the County has determined that it is necessary to obtain a Consultant to provide sex offender counseling to adult and juvenile clients of the Probation Department;

WHEREAS, the parties hereto desire to amend the Agreement to include services for both adult and juvenile clients, hereby amending the **TITLE of the AGREEMENT**;

WHEREAS, the parties hereto desire to amend the Agreement to update the rates, increase the not-to-exceed amount, and add travel policy information, hereby amending **ARTICLE III – Compensation for Services**;

NOW THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this Second Amendment to Agreement #8070 on the following terms and conditions:

I. The TITLE of the AGREEMENT is amended in its entirety to read as follows:

II. ARTICLE III, Compensation for Services, of the Agreement is amended in its entirety to read as follows:

Compensation for Services: For services provided herein, including any deliverables that may be identified herein, County agrees to pay Consultant upon the satisfactory completion and County's acceptance of work, monthly in arrears and within forty-five (45) days following the County's receipt and approval of itemized invoice(s) identifying services rendered.

For the purposes of this Agreement, the billing rates shall be:

- Sliding Fee Discount Program Clients \$75 per session
- Individual or Family Session (50 minutes) \$175 per session
- Individual or Family Session (30 minutes) \$87.50 per session
- Group Session (90 minutes) \$100 per attendee per session
- Probation/Parole File Review \$125
- Administration of Polygraph Exam \$500
- Testifying in Court (four [4] hour minimum) \$200 per hour*
(includes preparation, attendance, and transportation costs)
- Reports, Letters, and Other Services \$125 per hour*
(may include telephone conversations lasting longer than ten [10] minutes, attendance at meetings with other professionals County has authorized, preparation of records or treatment summaries, and time spent performing any other service County requests)
- Additional Psychological Testing \$175 per assessment
(PSI, MMPI-2/MMIP-3, STABLE-2007, LS/CMI)

*Hourly costs prorated for less than one (1) hour increments.

Mileage and travel (i.e. overnight lodging, meals, parking, airfare, bridge tolls, and other per diem expenses) will be reimbursed for services performed by Consultant or any authorized subconsultant and shall not exceed the rates to be paid to County employees under the current Board of Supervisor's Travel Policy in effect at the time the expenses are incurred. Any individual travel expense exceeding one hundred dollars (\$100) and any work requiring an overnight stay must be approved in advance by County's Contract Administrator or designee. Consultant is responsible for cancelling hotel rooms before the cancellation period ends and should record the cancellation number in case of disputes. Consultant shall not be reimbursed for "no-show" hotel charges unless there are unavoidable reasons for not cancelling the room and County's Contract Administrator or designee has determined that the reasons are valid.

The total amount of this Agreement shall not exceed \$175,802.00, inclusive of all costs, taxes, and expenses.

Itemized invoices shall follow the format specified by County and shall reference this Agreement number on their faces and on any enclosures or backup documentation. Copies of documentation attached to invoices shall reflect Consultant's charges for the specific services billed on those invoices. Invoices shall be mailed to County at the following address:

In the event that Consultant fails to deliver the documents or other deliverables required by the scope of services pursuant to this Agreement, County at its sole option may delay the monthly payment for the period of time of the delay, cease all payments until such time as the deliverables are received, or proceed as set forth herein below in the Article titled "Default, Termination, and Cancellation."

Except as herein amended, all other parts and sections of that Agreement #8070 shall remain unchanged and in full force and effect.
