Ms. Stout,

The El Dorado County Fire Protection District is respectfully requesting the use of our Development Impact Mitigation Fees for the purchase of the necessary equipment for our new ladder truck. The ladder truck is an addition to our fleet and the purchase was partially funded using our Development Impact Mitigation Fees.

The addition of the new ladder truck is essential to address the potential fire concerns with the increased commercial and residential development within the Shingle Springs area and across our district. However, the apparatus must be fully equipped for our firefighters to effectively do their jobs to mitigate emergencies.

The following list outlines the equipment we are requesting to purchase using development impact fees to outfit the ladder truck, all amounts are estimates from vendor quotes:


