Dear Supervisors,

I strongly urge you to support Supervisor Lori Parlin's recommendation to the Board, item 17, 22-0675 listed on the BOS meeting agenda for Tuesday, April 12, 2022.

Cool residents are very concerned about the impending changes to our Rural Center environment. Presently 8 of 22 commercial properties are on the market. Because Cool has no governmental authority aside from representation by our District 4 Supervisor, Cool has no means of protecting itself from badly imagined and incompatible growth. We need your help, as do other County Rural Centers. We must have, at a minimum, the ability to have a voice in Design Review Standards and Design Overlays.

Cool is rural, we do not want to urbanize, nor become a rural eyesore. We want more ability to control the destiny of Cool and Pilot Hill. Folks are moving here to escape urban areas and that type of life and growth. We want to see the dark night skies without light pollution blurring the view.

It's important that our voices be taken into account by the BOS and the County Planning Staff to protect our quality of life. Supporting Supervisor Parlin's Recommendation is a beginning to this greatly needed process for Cool and other County Rural Centers. We would be honored if you did.
