SOLUTION OVERVIEW

The current printing solution will be transitioned from the existing DP65 onto the 4110-EPS print system. All current printing will be migrated and any queues and paper trays configurations will be rebuilt.

El Dorado County prints jobs formatted using VIPP. The print jobs come from the IBM mainframe using VPS over TCP/IP. The VIPP user libraries will be migrated with the assistance of El Dorado County's IT staff who manages the current resource libraries.

PROJECT COMPONENTS

The breakdown below shows the requested project consulting components for the local Sacramento Xerox consultant team for selected phases of the 4110-EPS Printing System Project. It details the tasks to be performed by the local Xerox consultant (Professional Services) team. All tasks listed are modular and are a best effort to anticipate expected requirements by El Dorado County's management for items not covered by other project members.

Target completion dates for each task will be agreed upon by Xerox and EDS following proposal acceptance. Any tasks not listed below are not part of this project scope but can be added separately if desired.

Following is a breakdown of the services included with the project:

Operator Training

- 1 Onsite operator training class for up to 4 people
(Not to exceed 4 hours duration)

System Administrator Training

- 1 Onsite system administrator class for 1 person
(Not to exceed 4 hours duration)

- ❑ Project management
- ❑ Work with EDS Systems group with VIPP migration and testing
- ❑ Build print queues to accommodate local workflow
- ❑ Application testing and validation
