My name is Jeannette Wilson. My husband Michael Indiveri and I are writing to encourage you and members of the Board, to refrain from voting to support the Resolution submitted by the Patriots PAC (Item 41).

We believe that California is leveling the playing field, for California, through Prop 50. Money that CA receives from the federal government finds its way to El Dorado County and helps this county.
