An item as important as changing the dates of the election cycles of the EID Board of Director's should have been more widely publicized than just a notification on the EID website four days before a board meeting.

We strongly object to the EID Board of Directors considering adoption of the resolution found below without your rate payers/voters consideration. Any change of this magnitude must first be brought to the voters for their scrutiny. Without doing so, gives the impression that the current EID BOD is simply maneuvering to extend the terms of three of their members who would therefore not have to defend their positions for another year.

Also, no Directors should be appointed by the Board as part of this process. All Directors should need to declare and run for office so the public has the opportunity to consider whom they wish to serve the rate payers of EID.
