

## RESOLUTION NO. 011-2010 OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

# Resolution to Terminate and Abandon Offer Of Dedication Russell-Promontory, LLC Alexandra Drive

WHEREAS, the El Dorado County Board of Supervisors exercises the authority established by Section 66477.2 of the Subdivision Map Act, which authorizes the Board of Supervisors to terminate and abandon Offers of Dedication for any streets, paths, alleys, public utility easements, rights of way or storm drainage easements; and

WHEREAS, an Offer of Dedication for an easement for road and public utility purposes, from Russell-Promontory, LLC, an Illinois limited liability company, to the County of El Dorado, was recorded on November 20, 2001, as Document No. 2001-0075502 of Official Records of the County of El Dorado, attached hereto; and

WHEREAS, said offer was not presented to the County of El Dorado Board of Supervisors for approval and acceptance; and

WHEREAS, said offer remains in effect and runs with the land until such time the County of El Dorado Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution; and

WHEREAS, the County of El Dorado Board of Supervisors has determined that it is in the public's best interest to terminate and abandon said offer, at this time.

NOW, THEREFORE BE IT RESOLVED, that from and after the date this Resolution is recorded, said offer is hereby terminated and abandoned, at this time, by the County of El Dorado Board of Supervisors.

#### Parcel B


