



RESOLUTION NO. 179-2022

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WASTE CONNECTIONS OF CALIFORNIA, INC., dba
EL DORADO DISPOSAL SERVICE
Material Recovery Facility**

WHEREAS, a public hearing was held on December 6, 2022, for the purpose of adjusting the Material Recovery Facility (MRF) collection rates in the Waste Connections of California, Inc., dba, El Dorado Disposal Service; and

WHEREAS, County Ordinance section 8.42.150 provides that the Board of Supervisors shall set the rates to be charged by a franchisee at such time as the Board deems appropriate; and

WHEREAS, pursuant to County Ordinance section 8.42.170, the franchisee has provided written notice to each ratepayer of the proposed adjustment in a form approved by the County of the time, date, and place of the public hearing to set rates, and the notice was provided at least ten but no more than sixty days before the public hearing; and

WHEREAS, pursuant to County Ordinance section 8.42.170, a notice of the time, place, and purpose of the public hearing has been published in a newspaper of general circulation printed and published in the County, one each week, for two consecutive weeks prior to such hearing; and

WHEREAS, on August 30, 2022, the adoption of County Ordinance 5164 in compliance with SB 1383, necessitated the development and implementation of an organic waste recovery service which increased the burden on Franchisee El Dorado Disposal; and

WHEREAS, pursuant to the Rate Manual, Section 1, C, provides for rate setting outside the normal annual process for unforeseen circumstances that have or will materially affect the franchise hauler's revenues or costs under the Manual.

NOW, THEREFORE, be it resolved that due to unforeseen circumstances, effective January 1, 2023, the following Material Recovery Facility Self-Haul Organics gate rates are adjusted upward from \$15.00 to \$20.88 for the Placerville, CA, Material Recovery Facility gate rates:

Unsecured Load Fee

* A fee of twenty-five percent (25%) applied to the rate for the load will be imposed for any load being brought into the MRF without the vehicle being covered to prevent waste or recyclable material from blowing or falling from the load.

Recycling Incentive Fee

** A fee of twenty-five percent (25%) applied to the rate for the load will be imposed for any load of mixed waste that includes recyclable material. Recycling can be dropped off free of charge is segregated prior to entering the facility.
