EQUIPMENT DONATION/TRANSFER AGREEMENT

THIS Agreement made and entered by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and William H. Crim, a sole proprietor doing business as SAS Engineering, duly qualified to conduct business in the State of California, whose principal place of business is 5120 Clear Creek Road, Placerville, California 95667 (hereinafter referred to as "Contractor").

RECITALS

WHEREAS, Contractor has been engaged by County to provide monitoring and maintenance/repair services for security systems installed by Contractor under existing Agreement for Services #224-S1610, dated December 9, 2015, incorporated herein and made by reference a part hereof; and

WHEREAS, Contractor notified County that Contractor will be retiring and going out of business;

WHEREAS, Contractor desires to transfer to County the existing security alarm equipment installed and owned by Contractor and currently in use at County facilities ("Equipment"); and

WHEREAS, County intends to contract with another vendor to provide monitoring and maintenance/repair services for the Equipment; and

WHEREAS, County is willing to accept the transfer of the Equipment under the terms and conditions set forth herein.

NOW, THEREFORE, it is agreed as follows:

A. Equipment. Contractor agrees to transfer to County all right, title, and ownership of the Equipment listed in Exhibit "A" marked "List of Donated Equipment," incorporated herein and made by reference a part hereof, free and clear of all liens, claims and/or encumbrances. No monetary consideration shall be due to Contractor for the transfer of Equipment under this Agreement.

B. Use of Equipment. County may use the Equipment for any purpose it deems appropriate and there is no expectation of reversion of the Equipment to Contractor under any circumstances.

C. Contractor represents and warrants that donation of the Equipment does not violate any covenant, agreement or other obligation to which Contractor is a party; that Contractor is duly authorized to make the donation; and that there are no liens, claims, or other encumbrances of any kind against or upon title to the Equipment.

D. Effective upon execution of County's agreement with another vendor to provide monitoring and maintenance/repair services for the Equipment, Contractor will no longer be responsible for the Equipment, and disclaims any responsibility for the suitability or functionality of the future use of the Equipment. Contractor agrees to transfer title of the security equipment, wiring, batteries, etc. to El Dorado County. El Dorado County shall indemnify, defend and hold harmless William H. Crim and his agents against all claims, losses and defense attorney's fees that occur as a result of the use or dependence on the alarm equipment or systems left in the buildings by SAS engineering.

E. Any dispute resolution action arising out of this Agreement, including, but not limited to, litigation, mediation or arbitration, shall be brought in El Dorado County, California, and shall be resolved in accordance with the laws of the State of California. Consultant waives any removal rights it might have under Code of Civil Procedure Section 394.

F. In the event any provision of this Agreement is ruled invalid or unenforceable, such provision shall be severable from the remainder of this Agreement and the validity and enforceability of the remaining provisions shall not be affected or impaired in any way.

G. This document and the documents referred to herein or exhibits hereto are the entire Agreement between the parties and they incorporate or supersede all prior written or oral Agreements or understandings.

H. The County officer or employee with responsibility for administering this Agreement is Russ Fackrell, Facilities Manager or successor.

I. The parties to this Agreement represent that the undersigned individuals executing this Agreement on their respective behalf are fully authorized to do so by law or other appropriate instrument and to bind upon said parties to the obligations set forth herein.
