## FUNDING AGREEMENT #7465 AMENDMENT I

This First Amendment to that Funding Agreement #7465, is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Boys and Girls Club of Lake Tahoe, a California Non-Profit Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 1100 Lyons Avenue, South Lake Tahoe, California 96150, (hereinafter referred to as "Subrecipient");

#### RECITALS

WHEREAS, Subrecipient has been engaged by County to furnish personnel, equipment, office supplies, travel and other materials to provide a range of community services and education to vulnerable populations to promote prevention and equitable recovery from COVID-19/SARS-Co V-2., pursuant to Funding Agreement #7465, dated June 6, 2023, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date of June 30, 2024, for one (1) additional year, with the option to further extend the Agreement for one (1) extra additional year, to align with the extension of COVID-19 ELC68 expansion funding, amending ARTICLE II, Term;

WHEREAS, the parties hereto desire to amend the Agreement to update ARTICLE XIII, Notice to Parties and ARTICLE XXIX, Contract Administrator to include updated contract provisions;

WHEREAS, unless otherwise specified herein, the following terms and conditions shall be effective upon final execution of this First Amendment to that Funding Agreement #7465.

**NOW THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Subrecipient mutually agree to amend the terms of the Agreement in this First Amendment to Agreement #7465 on the following terms and conditions:

1) ARTICLE II, Term, of the Agreement is amended in its entirety to read as follows:

#### ARTICLE II

**Term:** This Agreement shall become effective when fully executed by the parties hereto and shall expire on June 30, 2025, unless terminated earlier pursuant to the provisions contained herein this Agreement under Article titled, "Default, Termination, and Cancellation," or Article titled, "Fiscal Considerations."

Based on an extended term date of County's California Department of Public Health (CDPH) Allocation No. COVID-19 ELC68, Subrecipient may earn one (1) single year extension with the same terms/conditions contemplated in Article I, Payment and Use of Funds, or as amended, not to exceed the end date of June 30, 2026.

To earn each extension, Subrecipient must meet the minimum requirements of this Agreement during the previous term. Following review and approval of performance, the Contract Administrator shall submit a request to the HHSA Director justifying a one-year extension. Upon approval by HHSA Director, vendor will be notified of the extension in writing, in accordance with the Article titled "Notice to Parties."

Notice by electronic email shall be served by transmitting the notice to all required email addresses and deemed delivered and received two (2) business days after service.

Contract Administrator: The County Officer or employee with responsibility for administering this Agreement is Heather Orchard, MSN, FNP, PHN, Public Health Nursing Supervisor, Public Health Division, HHSA, or successor. In the instance where the named Contract Administrator no longer holds this title with County and a successor is pending, or HHSA has to temporarily delegate this authority, HHSA Director shall designate a representative to temporarily act as the primary Contract Administrator of this agreement and shall provide the Subrecipient with the name, address, email, and telephone number for this designee via notification in accordance with the Article titled "Notice to Parties" herein.
