Abandonment of Easement #2007-05
Final Map for a Portion of Vista Del Lago, Unit One, Lot 4

WHEREAS, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

WHEREAS, public utilities easements, as shown on the Final Map for a Portion of Vista Del Lago, Unit One, were irrevocably offered in perpetuity to the County of El Dorado in October of 1990, and the Board of Supervisors accepted said offer in January of 1991; and

WHEREAS, the Department of Transportation has received an application from Michael Lee and Susan Lee, Trustees for the Lee Family Trust of 02/04/1993, requesting that the County of El Dorado vacate the public utilities easement located on a portion of the back boundary line of Lot 4; and

WHEREAS, A T & T, Comcast, El Dorado Irrigation District, and Pacific Gas & Electric have not used said easements for the purpose for which it was dedicated or acquired and find that no present or future need exists for said easements and do not object to the vacation; and

WHEREAS, all other existing easements will remain; and

WHEREAS, the Department of Transportation has determined that said easements herein described in Exhibit "A" and depicted in Exhibit "B", and made a part hereof, have not been used for the purpose for which they were dedicated preceding the proposed vacation, and has no objection.

NOW, THEREFORE BE IT RESOLVED, that from and after the date this Resolution is recorded, said public utilities easements described in Exhibit "A" and depicted in Exhibit "B" are vacated and no longer constitute a public utilities easement. In addition, a Certificate of Correction is hereby authorized to be signed and may be recorded by the County Surveyor.
