## FIRST AMENDMENT TO AGREEMENT FOR SERVICES #4588

**THIS FIRST AMENDMENT** to that Agreement for Services #4588 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Julia B. Vanderschaaf, LMFT, an individual, duly qualified to conduct business in the State of California, whose principal place of business is 6183 3<sup>rd</sup> Avenue, Sacramento, California 95817 (hereinafter referred to as "Consultant");

### RECITALS

**WHEREAS**, County has determined that it is necessary to obtain a consultant to assist its District Attorney's Office, in victim witness case management and mental health services for crisis response and victim services, pursuant to Agreement for Services #4588, dated February 24, 2020, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to revise the services rendered date, amending **ARTICLE I, Scope of Services**;

**WHEREAS**, the parties hereto desire to amend the Agreement to extend the expiration date for one (1) additional year, to December 31, 2021, amending **ARTICLE II, Term**;

**WHEREAS**, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$10,000, for a total not-to-exceed amount of \$17,000, amending **ARTICLE III, Compensation for Services**;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

I. **ARTICLE I, Scope of Services**, the last paragraph of the Article is amended in its entirety to read as follows:

Meeting or session durations are billed at one (1) hour intervals, and may exceed one (1) hour in length. In accordance with grant policies, the services are to be rendered by September 30, 2021.

II. **ARTICLE II, Term**, of the Agreement is amended in its entirety to read as follows:

This agreement shall become effective upon final execution by both parties hereto and shall expire December 31, 2021.


III. **ARTICLE III, Compensation**, the fourth paragraph of the Article is amended in its entirety to read as follows:

The total amount of this Agreement, as amended, shall not exceed \$17,000, inclusive of all costs, taxes, and expenses. \$7,000 may be used for mental health and case management services for the grant period of February 24, 2020 through September 30, 2020, and \$10,000 may be used for the grant period of October 1, 2020 through September 30, 2021.

Except as herein amended, all other parts and sections of Agreement for Services #4588, shall remain unchanged and in full force and effect.
