RELATED TO REZONING IN THE GEORGETOWN RURAL CENTER, (PAYE):
Section 1. The Official Zoning Map for the Georgetown Rural Center is hereby amended to rezone the following described lands:
Georgetown Rural Center:
Assessor's Parcel No. 061-071-026, being described as a portion of Section 1, T12N, R10E, M.D.M., consisting of 103.6 acres as shown on Exhibit A hereto.
The southern parcel as shown on Exhibit A hereto is hereby amended:
From: Open Space (OS)
To: Residential Estate Five-Acres (RE-5)
Zoning Map Correction: On December 15, 2015, as part of the Targeted General Plan Amendment-Zoning Ordinance Update (TGPA-ZOU) Project, the entirety of the parcel was re-mapped from Residential Estate 10-Acres (RE-10) to Open Space (OS) in error. The northern parcel as shown on Exhibit A hereto is hereby amended:
From: Open Space (OS)
To: Residential Estate 10-Acres (RE-10)
Section 2. This ordinance shall take effect and shall become effective thirty (30) days following the adoption hereof.
