Re: Agreement with West, a Thomson Reuters business for On-Line Legal Publications/Research

Honorable Supervisors:

#### **Recommendation:**

County Counsel recommends that the Board of Supervisors approve the submitted agreement for on-line legal publications/research with West, a Thomson Reuters business.

#### **Reason for Recommendation:**

West provides on-line legal data bases which contain a variety of legal publications, treatises, legal resources and case law. County Counsel has been using comparable services either through West or Lexis Nexis since the late 1980's. This agreement is a three year term which will realize the greatest long term savings in both on-line research and print publications. With the three year agreement West will reduce the monthly fee by 40%, for a savings of \$978.00 per month, as indicated in the agreement in addition to reducing all print products by 50%, for a savings of \$8,900.00 per year, as shown in the attachment to this letter.

Included with this agreement is a bridge amendment to provide service free of charge between the date of ratification of the agreement and July 1<sup>st</sup>, 2010 which is the official effective date of the agreement.

We are also requesting that the Chairperson ratify the signature and initials on the agreement of Louis B. Green which indicate acceptance to the specifics and usage terms of the agreement.

This agreement contains a fiscal out clause with 30 days written notice.

#### **Fiscal Impact:**

Fiscal year cost of Agreement is \$17,604 which is budgeted in the 10/11 budget and will be budgeted in future budgets. The offset for the fiscal year cost is a reduction in legal print publication of \$8,900.

### **Actions to Be Taken After Board Approval:**

Chairperson of the Board to sign the agreement with West, ratify Louis B. Green's initials and signature on said Agreement and forward to County Counsel for processing.
