# AGREEMENT FOR SERVICES #844 (447-S1711) AMENDMENT V

**This Amendment V** to that Agreement for Services #844 (447-S1711), made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Netsmart Technologies, Inc., a Delaware Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 4950 College Boulevard, Overland Park, KS 66211 (hereinafter referred to as "Contractor");

#### RECITALS

**WHEREAS**, the parties hereto have mutually agreed to retroactively add the following service: myLearningPointe; and

**WHEREAS**, the parties hereto have mutually agreed to remove the following service: Telehealth<sup>TM</sup> Subscription; and

**WHEREAS,** the parties hereto have mutually agreed to update the Netsmart Master Agreement for SAAS Licensed Software and Services Table of Contents and the Master Agreement Expenditures to reflect the aforementioned changes; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #844 shall be amended a fifth time as follows:

The initial term for provision of support services for Licensed Programs will begin on contract signing through May 31, 2017, with the following June 1, 2018 being the Anniversary date. Unless prices are shown above for renewal terms after the initial term, Contractor will give County not less than sixty (60) days written notice prior to any Anniversary date (as defined in the Agreement for services) of any revised schedule of support service prices. If prices for renewal terms are not fixed above, support service pricing will not be increased for any renewal term by more than 4%. All renewal terms are at the County's option.
