4.3 Coordinate: Navigational Network

Stanislaus State begins the El Dorado/Alpine County Cohort on June 23, 2025, using a hybrid schedule. In-person sessions will be at Light of the Hills Church in Cameron Park. The education facility has been provided for use at no cost to the commission. Stanislaus State has finalized the application process and sent invitations to thirty-one of forty-seven applicants to join the Summer 2025 cohort. Fifteen applicants are on the wait list and future cohort lists.

Stanislaus State and Mountain Valley Health Plan guided applicants through the application and scholarship process. Participants who complete the training will receive a \$1,600 incentive and transferable CSU credit. Staff worked with local CBOs and partner agencies to recruit applicants.
