What is the need that your project/program that you are requesting funds for supports?

We currently cannot accommodate disabled or mobility compromised combat veterans into hunt program due to their inability to access the waterfowl blind.

Many of our veteran candidates require assistance due to service related injuries or age related challenges.

Please provide information (DATA) demonstrating the need exists for VETERANS in El Dorado County.

2 out of 10 candidates listing to enroll in the program were unable to meet the physical demands required to participate in 2026.

1 vet due to service injury and 1 vet due to advanced age from the Vietnam war era.

2 vets in the program from prior years unable to return due to back related injuries from battle.

How will this program/project in this grant request address the need described above?

This will eliminate these veterans from feeling left out which is the entire point of the program - to welcome vets back into society through the brotherhood and sisterhood of the outdoors.

How is your organization suited to meet this need? Please describe how organization's mission aligns with the need and the program/project that funding is being requested for.

This will allow our organization to accommodate a broader spectrum of veterans with various physical abilities. Nobody will be left behind.

What is the grant timeline and major milestones of this project?

Upon award of funds we would immediately begin looking to acquire the UTV vehicle.

What are the measurable objectives of the project/program that you are requesting grant funds for?

We would document physically challenged veterans who benefit from the purchase and report the progress to the VAC annually.

How will the objectives be measured?

On an active up to day basis via our vet hunt photos on facebook.
On an annual report given orally to the VAC showing the vets who benefited.

What percentage of your total clientele are veterans? 100

We will require veterans to provide proof of service to the program which we will document.

What is the anticipated impact of the project?

No Veteran will be Left Behind in our program.

How will you measure the impact of this project/program?

By counting the amount of vets it helps annually and over time accumulating that data.

The entire point of the program is to welcome combat veterans back into society through the brother and sisterhood of the outdoors. By belonging to this program with the camaraderie it provides it gives them an opportunity to BELONG. PTSD fueled suicide rates lower when a person belongs to others who care about him. There is no way to measure if our program stops a suicide. We can only hope it helps.

As for a metrics for the program - we would count the amount of participants as it will grow annually.

We have funded and operated our program for 5 years through fundraising auction banquets which will continue to supply operating expenses.
